CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely **JSS Institute of Education, Huvinahadagali, Bellary District, Karnataka-583219** Vide SRC (NCTE) order No. F.SRO/NCTE/B.Ed./2004-2005/8983 dt. 01-12-2004 for Secondary **B.Ed. course** of one-year duration from the academic session 2004-2005 with an annual intake of **100** students.

2. **AND WHEREAS**, permission was hereby accorded by SRC to **JSS Institute of Education, Huvina Hadagali, Holagundi Road, Bellary District, Karnataka-583219** to shift the premises to the new location/building at **S.No.684-G, P.O. Box no.1, Near Gadidurgamma Temple, Holagundi Road, Huvinahadagali, Bellary District, Karnataka-583219** vide order no. F.No. APS01928/B.Ed./KA/2011-12/29668 dt. 22.07.2011

3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 17.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A provisional revised recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. programme of two years duration with an annual intake of 100 (two basic units) of 50 students each from the academic session 2015-16.**

4. **AND WHEREAS**, the institution has submitted vide letter dated 19.11.2016 request to 2 units to 1 unit. The SRC in its 324th meeting held on 07th – 08th December, 2016 considered the matter and decided to reduce intake 2 units to 1 unit. Accordingly, as per the decision of SRC a letter was issued to the institution on 16.12.2016 reduction intake 2 units to 1 unit.

5. **AND WHEREAS**, the SRC in its 344th Meeting held on 17th& 18th August 2017 considered the reply for the decision of 330th Meeting and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on dt. 09.09.2017

6. **AND WHEREAS**, the SRC in its 381st meeting held on 31st October & 01st November 2019 considered the matter and decided to issue Final Show Cause Notice to all such institution who has not submit reply against Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 10.09.2020. A reply of Final Show Cause Notice was received on dt. 08.10.2020.

7. **AND WHEREAS**, the SRC in its 390th meeting held on 28th – 29th October, 2020 considered the matter and decided to issue withdrawal order. Accordingly, as per the decision of SRC a withdrawal order No. F.SRO/NCTE/APS01928/ TN/B.Ed./2020/20597-0603 dated 06.11.2020 was issued to the institution.

8. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.89-13/E-174014/2021 Appeal/14th Mtg.-2021/29th May, 2021 dated 04.06.2021 appeal remand back the Order appealed against. The institution has submitted reply of appeal remand back vide letter dated 09.06.2021 along with documents.

9. **AND WHEREAS**, the matter was further considered by the SRC in its 399th meeting held on June 15th – 16th, 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **JSS Institute of Education, Holagundi, 684G, Holagundi Gramapanchayath, Ittigi Hobli, Huvinahadagali Tq. Bellary District-583219, Karnataka for B.Ed. programme for 1 basic unit of 50 students.**"*

10. **NOW THEREFORE**, the SRC decided to permit the institution i.e., **JSS Institute of Education, Holagundi, 684G, Holagundi Gramapanchayath, Ittigi Hobli, Huvinahadagali Tq. Bellary District-583219, Karnataka** run by **JSS MahavidyaPeetha, Ramanuja Road, Mysore-04** for continuation of recognition for **B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit)** subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme (s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
The institution shall be free to post additional relevant information, if it so desires.
- j. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.

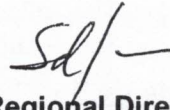
