WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Ravoof & Vazir Khans Memorial College of Education, S. No. 278/3, P. No. 67-83. Chanpuram Panchayat, Srikakulam District, Andhra Pradesh-532001 run by Vazir Khan Memorial Educational Society, Srikakulam, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2007-2008/13590 dt. 26.10.2007 for conducting Secondary (B.Ed.) course of one year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 19.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS, a corrigendum was issued to the institution vide order no. F.SRO/NCTE/APSO7944/B.Ed./AP/2015/68061 dt. 22.06.2015 for grants of recognition to Ravoof & Vazir Khans Memorial College of Education, S. No. 278/3, P. No. 67-83, Chanpuram Panchayat, Srikakulam District, Andhra Pradesh-532001 for conducting B.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 368th meeting held on 08th 09th January, 2019 considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 18.01.2019. The institution vide letter dated 30.01.2019 and 13.02.2019 submitted reply to the show cause notice.
- AND WHEREAS, the SRC in its 373rd meeting held on 26th 27th March, 2019 considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 08.04.2019. The institution vide letter dated 26.04.2019 submitted reply to the show cause notice
- AND WHEREAS, the SRC in its 377<sup>th</sup> meeting held on 03<sup>rd</sup> 04<sup>th</sup> July, 2019 considered the matter decided to Withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal order no. F.SRO/NCTE/APSO7944/B.Ed./AP/2019/106760-6765 dated 10.07.2019 was issued to the institution.
- AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. dated 18.02.2020 appeal remand back the Order appealed against
- AND WHEREAS, the SRC in its 385th meeting held on 03rdMarch 2020 considered the matter decided issue of Final Show Cause Notice. Accordingly, as per the decision of SRC a

Final Show Cause Notice was issued to the institution on 13.03.2020. The institution has submitted reply of Final Show Cause Notice on 10.08.2021.

- 9. AND WHEREAS, the SRC in its 405<sup>th</sup> meeting held on 13<sup>th</sup> 14<sup>th</sup> December, 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal order no. F.SRO/NCTE/APSO7944/B.Ed./AP/2021/129769 dated 31.12.2021 was issued to the institution.
- **10. AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-102/E-250447/2022 Appeal/5<sup>th</sup> Mtg.-2022 dated 12.07.2022 appeal remand back the order appealed against. The institution has not submitted reply to the appeal remand back case.
- 11. AND WHEREAS, the SRC in its 413<sup>th</sup> meeting held on 22<sup>nd</sup> 23<sup>rd</sup> August, 2022 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 05.09.2022. The institution has submitted reply on 12.09.2022.
- 12. AND WHEREAS, the SRC in its 417<sup>th</sup> Meeting held on 01<sup>st</sup> 02<sup>nd</sup> December, 2022 considered the matter and decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Ravoof & Vazir Khan's Memorial College of Education, S.No.278/3, P.No.67-83, Chapuram Panchayat, Srikakulam District-532001, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students.

- 13. NOW THEREFORE, this order is issued permitting the institution i.e., Ravoof & Vazir Khan's Memorial College of Education, S.No.278/3, P.No.67-83, Chapuram Panchayat, Srikakulam District-532001, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to and fulfilment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 14. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- **15.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 16. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 17. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 18. The institution shall make available the list of students admitted on its official website.
- 19. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
