WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **Rajiv Gandhi College of Education, Kattinayanapalli Village & Post, Krishnagiri-635001, Tamilnadu** run by **Sri Balaji Educational Trust, Krishnagiri District, Tamilnadu** vide SRC vide order no. F.SRO/NCTE/B.Ed./2006-2007/16027 dt. 17.12.2007 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students for two basic units** from the academic session 2015-16.

3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised provisional recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issue to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued to the institution on **28.03.2019**. The institution did not submit reply of Show Cause Notice.

4. **AND WHEREAS**, the SRC in its meeting 380th Meeting held on 18th – 19th September, 2019 the Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue SCN/FSCN. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 15.11.2019. The institution has submitted reply on 13.10.2021.

5. **AND WHEREAS**, the SRC in its 404th Meeting held on 16th & 17th November, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice. The institution has submitted its reply on 13.10.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. **At the time of recognition, the institution submitted a copy of sale deed dated 12.12.2004 in favour of Mrs. Sarasammal @ Sarasu. In response to FSCN the institution submitted sale deed dated 30.03.2012 in favour of Sri Balaji Educational Trust. The sale deed is different.**
2. **The institution has submitted photocopy of land document instead of certified/notarized.**

3. ***The institution has submitted photocopy LUC, NEC instead of Notarized/ Attested.***
4. ***The institution has submitted photocopy of Building Plan in which area of Multipurpose Hall not sufficient and not Approved by Competent Authority.***
5. ***The institution has submitted Site Plan but not approved by Competent Authority.***
6. ***The institution has submitted photocopy of Building Completion Certificate but not approved by Competent Authority.***
7. ***The institution has submitted photocopy of faculty list for B.Ed. programme for 2 units 1+12 faculty instead of 1+15 faculty.***
 - (i) ***The institution has not submitted latest faculty list.***

Hence, the Committee decided to **withdraw the recognition** granted to **Rajiv Gandhi College of Education, Kattinayanapalli Village & Post, Krishnagiri-635001, Tamilnadu** for conducting **B.Ed. programme** with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Rajiv Gandhi College of Education, Kattinayanapalli Village & Post, Krishnagiri-635001, Tamilnadu** run by **Sri Balaji Educational Trust, Krishnagiri District, Tamilnadu** for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students (2 basic units)** with effect from the academic session i.e., 2022-2023 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
