AND WHEREAS, the recognition was granted to the institution namely KBR College of Diploma in Education, Plot No. 1, Ward No. 1, Narasareddy Kandriga Village, Annamedu Post Office, Naidupetaa Taluka & City, Nellore District-524126, Andhra Pradesh run by KSR Memorial Charitable Trust for rural development, Plot No. 9-12, 2nd Floor, lalithanagar Village, Dilsukhnagar Post Office, Saroornagar Taluk, Hyderabad City, Ranagareddy District - 500060, Telangana for D.El.Ed and D.El.Ed-Al programme as per following details:-

- The SRC vide order no. F.No.SRO/APS09001/D.EI.Ed/AP/2015/62266 dated 03.03.2015 for conducting D.EI.Ed Programme of two-year duration with an annual intake of 50 students (one unit) from the academic sessions 2015-2016.
- (ii) The SRC vide order No. F.SRO/NCTE/SRCAPP2503/D.EI.Ed-AI/AP/2016-2017/85006 dated 02.05.2016 for conducting D.El.Ed-Al. Programme of two-year duration with an annual intake of 50 students each (two units) from the academic sessions 2016-2017.
- AND WHEREAS, a letter No. RC. No.359/A/SCERT/2019 dated 29.06.2020 is received from the Commissioner, School Education (FAC), School Education, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for deracination order in respect of 188 Pvt. D.El.Ed. College in A.P. since the said management of Pvt. D.El.Ed. College have made admission into the D.El.Ed. Course during academic year 2018-19 on their own in violation of Government.
- AND WHEREAS, the matter was considered by SRC in its 386th meeting held on 23rd-24th July, 2020 and decided to issue Show Cause Notice as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee perused the letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 received from Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. colleges have made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders.

Hence, the Committee decided to issue Show Cause Notice asking them to submit following documents/ to check adherence of NCTE Regulation, 2014.

- **4. AND WHEREAS**, as per the decision of SRC, a Show Cause Notice was issued to the institution on **21.08.2020** specifically seeking explanation on the observation made by the School Education Department, Govt. of Andhra Pradesh vide letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020. The institution vide letter dated 02.09.2020 submitted reply to Show cause Notice.
- 5. AND WHEREAS, The SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice issued to the institution on 16.10.2020. The institution vide dated 28.10.2020 submitted reply to the Final Show Cause Notice
- 6. **AND WHEREAS**, the matter was considered by the SRC in its 399th meeting held on 15th -16th June 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- 1. The Committee in its 386th meeting after perusal of the letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. colleges have made admissions into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders. Accordingly, the SRC decided to issue a Show Cause Notice to all such institutions asking therein to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. R.C.No. 359/A/SCERT/2019 dated 29.6.2020.
- 2. In view of the above decision a Final Show Cause Notice dt 21.08.2020 was issued to the institution and the institution vide dated 16.10.2020 has submitted its representation. The institution failed to submit satisfactory explanation on the observation made by the School Education Department, Govt. of AP is not satisfactory as the institution made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Govt. orders.
- 3. Further on perusal of the reply dated 16.10.2020 submitted by the institution, the institution also failed to submit the following documents/information:-
 - 1. The institution has submitted notarized copy of building plan wherein multipurpose hall size is 131.37 sq.mts which is insufficient. Further the approving authority is not readable.
 - 2. The institution has not submitted latest faculty list approved by the affiliating body.

Hence, the Committee decided to withdraw the recognition granted to KBR College of Diploma in Education, Plot No. 1, Ward No. 1, Narasareddy Kandriga Village,

Annamedu Post Office, Naidupetaa Taluka & City, Nellore District-524126, Andhra Pradesh for conducting D.El.Ed., D.El.Ed-Al course with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby **withdraw recognition** granted to KBR College of Diploma in Education, Plot No. 1, Ward No. 1, Narasareddy Kandriga Village, Annamedu Post Office, Naidupetaa Taluka & City, Nellore District-524126, Andhra Pradesh for **D.EI.Ed & D.EI.Ed-Al** programme with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
