## **ORDER**

The recognition us/14(1) of NCTE Act,1993 was granted to the institution namely, National College of Education, Sangareddy Revenue Division, Munidevunipalli Village, Kondapur Mandal, Medak District-502295, Telanganarun by Islamia Educational Society, Guntur, Telangana vide SRC (NCTE) order no. F.AP/NEW/B.Ed./154/SRO/NCTE/2003-2004/432 dt. 17.12.2003 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2003-04.

On promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 27.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, Revised Provisional Recognition order was issued to the institution on 14.05.2015for conducting B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 with a condition to maintain.

The SRC in its 342<sup>nd</sup> meeting held on 05<sup>th</sup> -06<sup>th</sup> July 2017 considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 13.07.2017.

The institution vide e-mail on 03.09.2019 requested to close the institution. The SRC in its 381<sup>st</sup> meeting held on 31<sup>st</sup> October to 01<sup>st</sup>November, 2019 considered the matter and decided to issue Withdraw order. Accordingly, as per the decision of SRC withdrawal order was issued on 13.11.2019 to the institution vide order no. F/SRO/NCTE/APSO0350/B.Ed./AP/2019/111645-165.

The institution aggrieved by the SRC withdrawal order dated 13.11.2019 preferred an appeal before the Appellate Authority, NCTE and the Appellate Authority vide its order dated 04.11.2020 has remanded the case back to the SRC.

The SRC in its 392<sup>nd</sup> meeting held on 15<sup>th</sup> -16<sup>th</sup>December, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 23.12.2020. The institution has submitted their reply to Final Show Cause Notice on 12.01.2021 alongwith documents and the Hon'ble High Court order.

The SRC in its 403<sup>rd</sup> meeting held on 18<sup>th</sup>-19<sup>th</sup> October 2021, considered the matter and decided that representation dated 02.01.2021 submitted by the Institute, there is no merit in the application as such the same cannot be considered. Therefore, the withdrawal was confirmed by the SRC.

वर्षेवं कुटुम्बकम् One earth • One family • One futude The institution filed a Writ Petition before Hon'ble High Court of Telangana bearing W.P. No. 2929 of 2022 titled as Islamia Educational Society and others vs. the State of Telangana & others Whereby the Hon'ble High Court has directed that: -

"Under these circumstances, the respondent No. 2-National Council of Teacher Education is directed to re-examine the reply, dated 02.01.2021, along with the material papers enclosed thereto, submitted by the petitioners, pursuant to the final show-cause notice vide No. F.SRO/NCTE/APS00350/B.Ed. / (TS)2020/21844, dated 23.12.2020, and pass orders in accordance with the governing rules, within a period of eight (8) weeks from the date of receipt of a copy of this order. With the above direction, this Writ Petition is disposed of."

The SRC in its  $413^{th}$  meeting held on  $22^{nd}-23^{rd}$  August 2022 has considered the matter and decided to issue a letter to the Registrar, Osmania University. Accordingly, as per the decision of SRC, a letter was issued to the Registrar, Osmania University on 05.09.2022.

The SRC in its 415<sup>th</sup> Meeting held on 03<sup>rd</sup> - 04<sup>th</sup> November, 2022 has considered the matter and the Committee decided to confirm the earlier withdrawal order dated 13.11.2019. Accordingly, as per the decision of SRC confirmation letter was issued to the institution on 15.11.2022.

Aggrieved by the order passed by the SRC dated 15.11.2022 the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-5/E-286652/2023 Appeal/3rd Meeting, 2023 APPLSRC202314512 dated 07.03.2023 has remanded the case back to the SRC.

The institution filed a Writ Petition before Hon'ble High Court of Delhi at New Delhi bearing W.P. (C) No. 12618 of 2023 titled as National College of Education vs. National Council for Teacher Education & Anr. Whereby the Hon'ble High Court has directed that: -

- "4. The aforesaid writ petition was disposed of with the following directions:-
- "(i) The NRC is directed to pass an order of restoration in favour of the petitionerinstitution for recognition of the concerned course in accordance with law within a period of seven days from the date of receipt of copy of the order passed today. The said order shall remain subject to the further decision to be taken by the concerned Regional Committee;
- (ii) The copy of the order of restoration of the recognition of the petitioner institution for the concerned course will have to be communicated to all concerned;
- (iii) Once an order of restoration is passed, the petitioner- institution would be entitled to participate in the counselling etc."
- 5. The directions passed in W.P.(C) 12235/2023 shall apply mutatis mutandis in the instant case also.

6. The instant petition stands disposed of."

Accordingly, in view of the order dt. 25.09.2023 passed by the Hon'ble High Court of Delhi at New Delhi and order dt. 07.03.2023 passed by Appellate Committee, the status of National College of Education, Sangareddy Revenue Division, Munidevunipalli Village, Kondapur Mandal, Medak District-502295, Telangana for B.Ed. Programme for two basis units of 100 students stands recognised and is entitled to the benefits of recognition until and unless fresh withdrawal order is passed. However, the same will remain subject to further orders to be passed by the SRC in terms of the order passed by the appellate authority on 07.03,2023.
