ORDER

The recognition us/14(3)(a) of NCTE Act,1993 was granted to the institution namely, **Nehru Memorial Ex-Servicemen Educational Society, Luthergiri, ITI Campus, Rajahmundry-533105, E.G. Dt., Andhra Pradesh** vide Order No. F.AP/B.Ed./New/78/SRO/NCTE/2000-2001/1727 dated 23.08.2000 for conducting B.Ed. Programme of one year duration with an annual intake of 100 students from the academic session 2000-2001.

Thereafter, A Revised Provisional Recognition Order (RPRO) was issued to the institution on 29.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students each (two basic units) from the academic session 2015-16.

The SRC in its 290th meeting held on 10th -11th July 2015 considered the representation dated 15.06.2015 from the institution and decided to permit shifting the institution to **NMES College of Education, Peddapuram Post, East Godavari District-533437, Andhra Pradesh** to **NMES College of Education, Ramesampeta Village, Anuru Road, Peddapuram Post, East Godavari District-533437, Andhra Pradesh**. Accordingly, shifting order was issued to the institution on 05.10.2015 vide order no. F.SRO/NCTE/APSO0375/B.Ed./AP/2015-16/74744.

The SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 30.04.2019. The institution failed to reply to the Show Cause Notice.

That Final Show Cause notice was issued to the institution on 14.10.2019. The institution submitted their reply to Final Show Cause Notice on 30.10.2019.

The SRC in its 388th meeting held on 14th -15th September, 2020 considered the matter and decided to withdraw the recognition. Accordingly, a withdrawal order was issued to the institution on 07.10.2020 vide order no. F.SRO/NCTE/AOPS00375/B.Ed./AP/2020/119155-9161.

Thereafter, aggrieved by the order passed by SRC, the institute filed a W.P No. 17123 of 2023 before the Hon'ble High Court of Andhra Pradesh. However a Writ Appeal was filed by NCTE against the order dated 18.08.2023 passed by the Single Judge in W.P. No. 17123 of 2023 having W.A No. 860 of 2023 titled National Council for Teacher Education vs. Nehru Memorial Ex-Servicemen College of Education before the division bench of Hon'ble High Court of A.P.

"6. It is suggested by Mr. N. Harinath, learned Deputy Solicitor General appearing for the appellant that in case the writ petitioner files a fresh appeal before the respondent No.5, the same would be considered and appropriate orders would be passed within one week from the date of receipt of the said memo of appeal."

7. *Learned counsel for the writ petitioner appearing before us has no objection to such a suggestion made and undertakes to supply the copy of the appeal through registered post/physically within two days from today. On such copies being supplied, as per the statement made by learned counsel for the appellant, the appeal shall be decided on its own merits, within one week, thereafter. The timelines are important for the purpose of disposal of the appeal filed by the writ petitioner considering the fact that the counselling process for the admissions into the various B.Ed. Colleges begins in the week commencing 04.09.2023. Be that as it may.*

8. *In the light of the aforementioned statement and the agreement arrived at between the parties, the present appeal as also writ petition No.17123 of 2023 shall stand disposed of. The impugned orders are hereby set aside. No order as to costs.*

Pending miscellaneous applications, if any, shall stand closed."

In light of above order, the institution preferred an appeal before the Appellate Authority, NCTE and the Appellate Authority vide its order dated 18.09.2023 has remanded the case back to the SRC.

Accordingly, in view of the order dt. 30.08.2023 passed by the Hon'ble High Court of Andhra Pradesh and order dt. 18.09.2023 passed by Appellate Committee, the status of **Nehru Memorial Ex-Servicemen College of Education, 206/12E Ramesampete, Anuru Road, Peddapuram, East Godavari, Andhra Pradesh-533437** for **B.Ed. Programme** for two basis units of 100 students stands recognised and is entitled to the benefits of recognition until and unless fresh withdrawal order is passed. *However, the same will remain subject to further orders to be passed by the SRC in terms of the order passed by the appellate authority on 18.09.2023.*

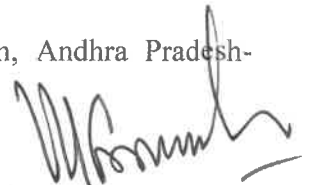
