In terms of Section 14(1) of the NCTE Act, 1993 Elite Educational Society, Draksharama, East Godavari Dt.-533 262, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Little Rose College of Education, Rajamundry Revenue Division, Elite Educational Society, Draksharama, East Godavari Dt.-533 262, Andhra Pradesh for Secondary (B.Ed.) course of One year duration for the academic session 2002-03 with an annual intake of 100 students.

AND WHEREAS an inspection team constituted by SRO-NCTE inspected the institution on 24.5.2002. The report of the inspection team along with other documents made available was placed in the 58th SRC meeting held on 6th and 13th March, 2003 and the Southern Regional committee decided to issue a Notice to the institution indicating deficiencies:-

AND WHEREAS your written representation and other documents submitted against the said notice was placed before SRC in its 60th meeting of SRC held on 9th May 2003 and SRC considered the written representation submitted by the institution and has observed that notice was issued to the institution for rejection and not for entertaining compliance. Therefore, SRC decided that the representation submitted by the institution for fake certificate and other deficiencies listed out in the notice cannot be accepted and decided to refuse recognition.

ACCORDINGLY, a rejection order vide order No. F.AP/NEW/B.Ed. /202/2002-03/7284 dated 14.5.2003 was issued to the institution under Section 14 of the NCTE Act, 1993.

AND WHEREAS, the NCTE, Headquarters after careful consideration of all aspects of the matter has noted that deficiencies pertaining to qualifications and experience of the Principal has been rectified by the institution. Whereas the claims of the institution with regard to the other deficiencies pointed out by the SRC need to be verified. So the case of the institution was remanded to SRC for consideration, after verification of the claims of the institution and also obtaining a final list of teachers and Principal duly countersigned by University authorities.

And Whereas a verification team constituted by SRC-NCTE verified the instructional, infrastructural and other facilities said to have been provided by the institution on 12.8.2003. The report of the verification team along with other documents made available was placed in the 63rd SRC meeting held on 16th August, 2003 and the Southern Regional Committee has came to the conclusion that deficiencies persisted in the institution. Therefore, SRC decided to refuse recognition to the institution.

Refusal order dated 29th September, 2003 was sent to the institution and the institution preferred an appeal on 2nd January 2004. In the Appeal Order dated 14th June, 2004. The Council advised SRC to issue a show cause notice to the appellant institution pointing out all the deficiencies and asking the institution to furnish the required information and then take a fresh on 16.12.2004.

On scrutiny of the written representation the matter was placed before 87th SRC meeting held on 10th January 2005, the Committee has noted that the institution has made compliance to the deficiencies pointed out in the Notice and has decided to accord recognition to the institution.

- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Little Rose College of Education, Rajamundry Revenue Division, Elite Educational Society, Draksharama, East Godavari Dt.-533 262, the academic session 2004-2005 with an annual intake of 100 students subject to fulfillment of the following:
 - a. The institution will ensure that **Principal and Seven** faculty members duly approved by the affiliating University are in position for an intake of **100** students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.
 - b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - c. The institution shall shift to its own premises/building within three years from the date of recognition(in case the course is started in rented premises)
 - d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- 3. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
- 4. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the Registrar of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

5. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
