WITHDRAWAL ORDER

WHEREAS, the recognition was granted to Amritalaya College of Education, Chinnamottur, Moorthiyur Village, Vanayambadi Road, Jolarpettai, Tirupattur, Vellore District, Tamilnadu the SRC vide order No F.SRO/NCTE/B.Ed./2006-2007/8764 dated 26.10.2006 for conducting B.Ed. course of one year duration from the academic session 2006-2007 with an annual intake of 100 students.

and whereas, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 10.02.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 12.05.2015 for conducting **B.Ed. course** of two years duration with an annual intake of 100 students each for two basic units from the academic session 2015-2016.

AND WHEREAS, the matter was finally considered the SRC in its 397th meeting held on 25th - 26th March, 2021 considered the matter and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines Issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 20.08.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

- 1. The institution has not submitted latest list approved by the affiliating University. As per the old Faculty list, the same is of consisting of one principal and 12 Lecturer against the requirement of 1+15 Lecturers. Some deficiencies are:
 - a. One Lecturer of performing arts is Part timer.
 - b. Faculty in r/o Fine Arts is not appointed by the institution.
 - c. The institution is required to submit a latest faculty list.
- 2. The institution has submitted a photocopy of the Building plan instead of certified/notarised one. The same is also not readable in terms of name and authority of the approving building plan.
- 3. The institution has submitted photocopy of NEC, Site plan instead of certified/notarized copy of these documents.

Hence, the Committee decided to withdraw the recognition granted to Amritalaya College of Education, Chinnamottur, Moorthiyur Village, Vanayambadi Road, Jolarpettai, Tirupattur, Vellore District, Tamilnadu for conducting B.Ed. course with effect from the next academia session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Amritalaya College of Education, Chinnamottur, Moorthiyur Village, Vanayambadi Road, Jolarpettai, Tirupattur, Vellore District, Tamilnadu for conducting B.Ed. course with effect from the next academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
