WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Smt Mannaru Yasodamma Memorial D.EI.Ed. College, Plot No. – 458/1, 458/3, ECR Ventur, Addanki Road, Darsi Village & Post, Darsi Taluk, Prakasam District, Andhra Pradesh-523247 run by Sri Anjani Putra Educational Society, Plot No. – 458/1, 458/3, ECR Ventur, Addanki Road, Darsi Village & Post, Darsi Taluk, Prakasam District, Andhra Pradesh-523247 vide order no. F.SRO/NCTE/SRCAPP3406/D.EI.Ed.-AI/AP/2016-17/84407 dt. 14.04.2016 for D.EI.Ed.-AI programme of two years duration with an additional intake of 50 students from the academic sessions 2016-2017.

2. AND WHEREAS, the institution has submitted a written representation on 07.06.2022 as under: -

We, Smt. Mannaru Yasodamma Memorial D.EI.Ed. College, Plot No. 458/1, 458/3, ECR Ventures, Addanki Road, Darsi Village & Post, Darsi Taluk, Prakasam District, A.P., having NCTE order no. F.SRO/NCTE/SRCAPP3406/D.EI.Ed./AP/2016-2017/84407, dated 14.04.2016 (copy enclosed) running under Sri Anjaniputra Educational Society, would like to inform you that we have stopped D.EI.Ed., admissions from the academic year 2017-2018. Hence, we would like to cancel FDs bearing nos. No. G 528656, dated 27.04.2016 for Rs. 5,00,000/- and No. G 528657, dated 27.04.2015 for Rs. 7,00,000/-."

3. AND WHEREAS, the SRC in its 414th Meeting held on 26th & 27th September, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution on 07.06.2022 by withdrawing the recognition granted to Smt. Mannaru Yasodamma Memorial B.Ed. College, Addanki Road, Darsi (P. O & M), Kandukur Revenue Division, Prakasam District, Darsi, Andhra Pradesh-523247 for conducting M.Ed. & D.El.Ed-Al Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing the recognition granted to Smt Mannaru Yasodamma Memorial D.EI.Ed. College, Plot No. 458/1, 458/3, ECR Ventur, Addanki Road, Darsi Village & Post, Darsi Taluk, Prakasam District, Andhra Pradesh-523247 run by Sri Anjani Putra Educational Society, Plot No. 458/1, 458/3, ECR Ventur, Addanki Road, Darsi Village & Post, Darsi Taluk, Prakasam District, Andhra Pradesh-523247 for conducting D.EI.Ed.-AI programme of two years duration with an additional intake of 50 students with effect from the next academic session i.e., 2022-2023 onwards.
- 5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
