WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Acharya College of Education, 89 & 90, Soladevana Halli, Hesaraghatta Main Road, Chikkabanavara Post, Bangalore, Karnataka-560090 run by J.M.J Education Society, Bangalore, Karnataka vide order no. F.SRO/NCTE/B.Ed./2004-2005/8857 dt. 30.11.2004 for Secondary (B.Ed.) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 09.03.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 30.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, an order vide no. F.SRO/NCTE/APS01865/B.Ed./KA/2015-16/70175 dt. 17.07.2015 for recognition accorded to Acharya College of Education, 89 & 90, Soladevanahalli, Hesaragahatta Main Road, Chikabanavara Post, Bangalore, Karnataka-560090 for B.Ed. course is hereby restored/Continued till further orders and permit to shift its premises to the new location/Building at Acharya College of Education, 89 & 90, Soladevanahalli, Hesaraghatta Main Road, Chikkabanavara Post, Bangalore, Karnataka-560090.
- 4. AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 18.08.2020. The institution did not submit reply to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 406th meeting held on 19th January, 2022 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 03.02.2022. The institution did not submitted reply to the Final Show Cause Notice.
- 6. **AND WHEREAS**, the SRC in its 414th Meeting held on 26th & 27th September, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

(i) The institution failed to submit reply to the Final Show Cause Notice dated 03.02.2022.

Hence the recognition granted to Acharya College of Education, 89 & 90, Soladevana Halli, Hesaraghatta Main Road, Chikkabanavara Post, Bangalore, Karnataka-560090 for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the academic year 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdrawthe recognition granted to Acharya College of Education, 89 & 90, Soladevana Halli, Hesaraghatta Main Road, Chikkabanavara Post, Bangalore, Karnataka-560090 run by J.M.J Education Society, 89 & 90, Soladevana Halli, Hesaraghatta Main Road, Chikkabanavara Post, Bangalore, Karnataka-560090 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the next academic session i.e., 2023-2024 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."
