WITHDRAWAL ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **M.R. College of Education, Fort Campus, Vizianagaram – 535002, Andhra Pradesh** vide order no. F.PN/SEC/N/128/SRO/NCTE/2004-05/5911 dt. 10.08.2004 for conducting Secondary B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted an affidavit on 27.01.2015 for its willingness of two units in B.Ed. course and adherence provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.**

2. **AND WHEREAS**, the SRC in its 404th meeting held on 16th – 17th November, 2021 considered the matter and decided to continuation order. Accordingly, as per the decision of SRC a Continuation order No. F.SRO/NCTE/AOSO0326/B.Ed/AP/2021/129340 was issued to the institution on 01.12..2021.

3. **AND WHEREAS**, the institution has submitted written representation vide letter dated 11.10.2023 request to close the B.Ed. programme. The SRC in its 433rd meeting held on 10th February, 2024 considered the matter and decided as under:-

The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

*The Committee agreed to close down the institution as requested by the Institution vide letter dated 11.10.2023 by withdrawing the recognition granted to **M.R. College of Education, Fort Campus, Vizianagaram-535002, Andhra Pradesh** for conducting **B.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2023-2024.*

The FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC.

4. **NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to **M.R. College of Education, Survey No. 498, Karpa West Ward Round Mahal, Fort Campus, Vizianagaram – 535002, Andhra Pradesh** for conducting

B.Ed. programme of two-years duration with an annual intake of (2 basic units) of 50 students each under clause 17(1) of NCTE Act, 1993 from the academic session 2023-2024.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
