CONTINUATION ORDER

WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, **Sri Annamacharya College of Education, New Boyanapalli (Post), Rajampet – 516115, Cuddapah District, Andhra Pradesh** vide Order No. F.AP/NEW/B.Ed/132/SRO/NCTE/2003-2004/9986 dated 17.11.2003 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students.

2. **AND WHEREAS**, the SRC in its 367th meeting held on 21st December 2018 considered the matter and decided that “is now being treated as a RPRO case for B.Ed. (2 Units of 50 students each)...”

3. **AND WHEREAS**, as per the decision of SRC a letter was issued to the institution on 07.01.2019. The Southern Regional Committee (SRC) in its 413th meeting held on 22nd & 23rd August, 2022 decided to issue a Show Cause Notice and the same was issued to the institution on 23.01.2023. The institution has submitted reply on 25.10.2023.

4. **AND WHEREAS**, the SRC in its 430th meeting held on 01st December, 2023 has considered the matter and decided as under:-

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

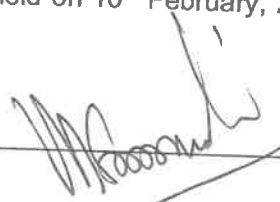
The Committee considered the reply dated 25.10.2023 in the order to reply Show Cause Notice dated 23.01.2023 and the Committee observed that the staff list submitted by the institution has many discrepancy and also noted that the SRC in its 367th meeting had observed that in spite of so many vacancies the affiliating University still gave them affiliation without difficulty.

Therefore, the Committee decided to issue letter to the affiliating body seeking report on the functioning of the institution as per provisions of the NCTE Regulations, 2014 and availability of the staff with the institution.

5. **AND WHEREAS**, as per the decision of SRC a later was issued to the Registrar, Yogi Vemana University on 20.12.2023. The institution has submitted reply on 02.02.2024 & the Yogi Vemana University has submitted report through e-mail received on 09.02.2024.

6. **AND WHEREAS**, the SRC in its 433rd meeting held on 10th February, 2024 considered the matter and decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Sri Annamacharya College of Education, Survey No. 1076/3, New Boyanapalli, Rajampet, Kadapa District-516126, Andhra Pradesh** for B.Ed. programme for 2 basic units of 50 students each.*

7. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Sri Annamacharya College of Education, Survey No. 1076/3, New Boyanapalli, Rajampet, Kadapa District-516126, Andhra Pradesh** for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;



- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available the list of students admitted on its official website.

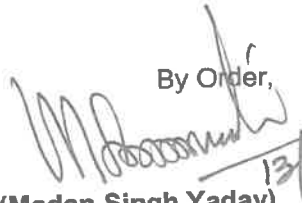
13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
