

WHEREAS, recognition u/s 14 (3) (a) was granted to the institution namely Sri Bharathi College of Education, Kaikkuruchi Village & Post, Alangudi Taluk, Pudukkottai District – 622303, Tamilnadu vide order No. F. SRO/NCTE/M.Ed /2006-2007/18660 dated 10.03.2008 for (M.Ed.) Course of one year duration with an annual intake of 25 students.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 was permitted to Sri Bharathi College of Education, Kaikkuruchi Village & Post, Alangudi Taluk, Pudukkottai District 622303, Tamilnadu vide order No. F.SRO/NCTE/2010-2011/20735 on 26.08.2010 from the session 2010-2011.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted an affidavit dated 27.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order (RPRO) was issued to the institution on 22.05.2015 for conducting M.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016
- **4. AND WHEREAS,** the SRC in its 388th Meeting held on 14th & 15th September, 2020 the matter was considered and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 08.06.2023. The institution has submitted reply on 25.06.2021 & 17.08.2023.
- 5. AND WHEREAS, the SRC in its 433rd meeting held on 10th February, 2024 has considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Bharathi College of Education, Survey No. 67/7A, 67/5A, 67/1, 68/1B, 69/1B, 67/5S, 67/5T, Kaikkuruchi Village & Post, Alangudi Taluk, Pudukkottai District-622303, TamilNadu for M.Ed. programme for 1 basic unit of 50 students."

6. NOW THEREFORE, this order is issued permitting the institution i.e., Sri Bharathi College of Education, Survey No. 67/7A, 67/5A, 67/1, 68/1B, 69/1B, 67/5S, 67/5T, Kaikkuruchi Village & Post, Alangudi Taluk, Pudukkottai District-622303, TamilNadu for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
