WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Jagath Guru College of Education, Plot No. 453, Sanikavaram Village & Post, Peddaraveedu Mandal Taluk, Prakasam District — 523331, Andhra Pradesh run by Lakshmi Ganapathi Educational Society, Plot No. 453, Sanikavaram Village & Post, Peddaraveedu Mandal Taluk, Prakasam District — 523331, Andhra Pradesh vide order No. F.SRO/SRCAPP14172/B.Ed/AP/2016/85189 dt. 02.05.2016 for conducting B.Ed. programme of two-years duration intake of 50 students (one unit) from the academic session 2016-2017.

- **2. AND WHEREAS**, the SRC in its 408<sup>th</sup> meeting held on 2<sup>nd</sup> March, 2022 taken the decision to issue **Show Cause Notice** to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulations, 2014. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 17.10.2022. The institution has submitted reply on 05.02.2024.
- **3. AND WHEREAS,** the SRC in its 433<sup>rd</sup> meeting held on 10<sup>th</sup> February, 2024 considered the matter and decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Jagath Guru College of Education, Survey No. 453, Sanikavaram Village & Post, Peddaraveedu Mandal Taluk, Prakasam District — 523331, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e. Jagath Guru College of Education, Survey No. 453, Sanikavaram Village & Post, Peddaraveedu Mandal Taluk, Prakasam District 523331, Andhra Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (1 basic unit) of 50 students subject to fulfilment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- **6.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 7. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
