WHEREAS, the recognition was granted to the institution namely, Sai Ram College of Education, No. 14A, Pidari West Street, Sirkali, Nagapattinam District - 609110, TamilNadu for Elementary course & Elementary (D.T.Ed.) as per following details:-

- The SRC vide Order No F.TN/ELE/NR-782/SRO/NCTE/2004-2005/9288 dt. 10.12.2004 for Elementary course of two-year duration with an annual intake of 50 students from the academic sessions 2004-2005.
- (ii) The SRC vide order No. F.SRO/NCTE/08/TN-AI/205-06/2764 dt. 03.09.2005 for Elementary (D.T.Ed.) course of two-year duration with an annual intake of 50 students and an additional intake of 50 students from the academic sessions 2005-2006.
- AND WHEREAS, the inspection conduct on 04.06.2011 and VT report received on 2. 08.06.2011. The SRC in its 387th meeting held on 24 - 25 August 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 01.09.2020. The institution has submitted reply on 17.09.2020.
- AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October, 2020 3. considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.SRO/NCTE/APSO0782/KA/D.T.Ed./2020/119791-119797 dated 21.10.2020 was issued to the institution.
- AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal 4. before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-287/E-171953/2020 Appeal/4th Mtg.-2020/21st January 2021 dated 15.02.2021 appeal remand back the Order appealed against. The institution has not submitted reply to the appeal remand back case.
- AND WHEREAS, the SRC in its 395th meeting held on 25th 26th Feb 2021 considered 5. the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 15.03.2021. The institution vide letter dated 03.04.2021 submitted written representation.
- AND WHEREAS, the SRC in its 400th meeting held on July 13th-14th, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dt. 15.03.2021 but the institution vide its reply letter dated 03.04.2021 only mentioned that they had forwarded the reply with all documents vide Speed Post dt. 01.03.2021 but the same has not been received in SRC, NCTE.

Hence, the Committee decided to withdraw the recognition granted to Sai Ram College of Education, No. 14A, Pidari West Street, Sirkali, Nagapattinam District – 609110, Tamil Nadu for conducting D.T.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sai Ram College of Education, No. 14A, Pidari West Street, Sirkali, Nagapattinam District 609110, Tamil Nadu run by Sai Ram Educational Trust, Sirkali 609110, Tamilnadu for conducting Elementary D.T.Ed. course along with the additional intake of two years duration with effect from the academic session i.e., 2021-2022 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
