### TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, A.E & C.S. Ramapriya College of Education, Bangalore-Chennai Bye Pass Road, Mulbagal, Kolar District, Karnataka-563131 run by Amrit Edcuational & Cultural Society, Bangalore, Karnataka vide SRC vide order no. F.SRO/NCTE/B.Ed./2004-2005/8667 dt. 25.11.2004 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 23.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of 100 students each for two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC issued a Corrigendum vide order F.SRO/NCTE/APSO2255 /B.Ed./KA/2015-16/82098 dated 19.02.2016 100 students of two basic units of 50 students each.
- AND WHEREAS, the SRC in its 381st Meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue SCN in all such mattes where the institution has not submitted the documents/VT report not accompanied with the requisite documents. Accordingly, as per decision of SRC a SCN was issued to the institution on 18.08.2020. The institution has not submitted reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 24.09.2020. The institution has submitted reply on 14.09.2020.
- AND WHEREAS, the SRC in its 401st meeting held on 11th 12th August, 2021 considered the FSCN reply matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 14.09.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The building plan is neither approved nor legible. Further the multipurpose hall is not available.
- 2. Total build-up area of 1771.90 sq. mt. is not sufficient as stipulated under appendix 4 of NCTE Regulations, 2014.
- 3. Proforma of faculty is not signed on each page and suffers from overwriting.
- 4. Details of website not submitted.
- 5. Form 'A' issued by the bank for FDRs of Endowment Fund and Reserve Fund not submitted.

Hence, the Committee decided to withdraw the recognition granted to A.E & C.S. Ramapriya College of Education, Bangalore-Chennai Bye Pass Road, Mulbagal, Kolar District, Karnataka-563131 for conducting B.Ed.programmewith effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to A.E & C.S. Ramapriya College of Education, Bangalore-Chennai Bye Pass Road, Mulbagal, Kolar District, Karnataka-563131 run by Amrit Educational & Cultural Society, Bangalore, Karnataka for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) for 50 students each with effect from the academic session i.e., 2021-2022 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
