WHEREAS, the recognition was granted to the institution namely, Natham P.R. College of Education, Punnappatti Village & PO., Dindigul Main Road, Uluppakkudi, Natham Taluk, Dindigul District, Tamilnadu-624401 vide SRC vide order no. F.TN/SEC/SRO/NCTE/2005-2006/1845 dt. 13.07.2005 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- AND WHEREAS, the SRC vide order no. F.No. APS03803/B.Ed/TN/2012-13/46799 2. dt. 19.10.2012 permitted the institution for shifting of premises to new location at N.P.R. College of Education, Punnappati Village and Post, Dindigul Main Road, Uluppakkudi, Natham Taluk, Dindigul-613007, Tamil Nadu.
- AND WHEREAS, the name of "N.P.R. College of Education, Punnappati Village and 3. Post, Dindigul Main Road, Uluppakkudi, Natham Taluk, Dindigul-613007, Tamil Nadu" is corrected as "Natham P.R. College of Education, Punnappati Village and Post, Dindigul Main Road, Uluppakkudi, Natham Taluk, Dindigul-624401, Tamil Nadu vide order no. F.No.APSO3803/B.Ed/TN./2013-14/49293 dated 05.03.2013.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 04.03.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16.
- AND WHEREAS, the inspection conduct on 25.10.2016 and VT report received on 27.10.2016. the SRC in its 388th meeting held on 14th – 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 08.06.2021. The institution has submitted reply on 24.06.2021 & 15.07.2021.
- AND WHEREAS, the SRC in its 401st meeting held on 11th 12th August, 2021 considered the request to closed the B.Ed. programme matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee agreed to close down the institution as requested by the institution vide letter dated 15.07.2021 by withdrawing the recognition granted to Natham P.R.

- (c) Resolution of the management to the effect for closure of the course."
- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Natham.P.R. College of Education, Punnappatti Village and Post, Dindigul Main Road, Uluppakkudi, Natham Taluk, Dindigul, Tamilnadu-613007 run by Titan Educational Trust, Chennai, Tamilnadu-17 for conducting B.Ed. programme of two years duration with effect from the academic session i.e., 2021-2022 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
