F.No.SRCAPP488/D.El.Ed/AP/2012/44907 dt. 02.08.2012 for conducting D.El.Ed. course of two-year duration with an annual intake of 50 students from the academic session 2012-2013.

AND WHEREAS, the institution vide letter dated 18.04.2019 received on 10.07.2019 requested for closure of D.El.Ed. programme. The SRC in its 379<sup>th</sup> meeting held on 21<sup>st</sup> - 22<sup>nd</sup> August, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided that to withdraw the recognition granted to Nagarjuna College of Education, Sy.No. 754, 19, 252, 266, Nagarjuna Nagar, Miryalaguda Village & Taluka, Nalgonda District-508207, Telangana for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the request of the institution. However, the Reserve Fund and Endowment Fund will be refunded by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course
