WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution P.S.N.L College of Education, No. 3/115 A, Venkatachalapuram Post, Sattur Taluk, Virudhunagar District, Tamilnadu-626203 for B.Ed.& B.Ed.-Al programme as per following details:-

- (i) The SRC vide Order No.F.SRO/NCTE/B.Ed./2006-2007/2843 dated 15.05.2007 to offer Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.
- (ii) The SRC vide order No.F.SRO/NCTE/SRCAPP2069/B.Ed.-AI/TN/2015/62165 dated 03.03.2015 for conducting B.Ed. (Additional Intake) programme of two-years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 29.04.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed.,B.Ed.-Al Programme of two years duration with an annual intake of 100 (two basic units) & 100 (two basic units) total 4 units from the academic session 2015-16.
- 3. AND WHERESAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue SCN/FSCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per decision of SRC a First Show Cause Notice was issued to the institution on 07.09.2020. The institution did not submit reply to First Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its 408th Meeting held on 2nd March 2022 considered the matter decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC, a Final Show Cause Notice was issued to the institution on 14.03.2022. The institution has submitted reply on 28.03.2022.
- 5. AND WHEREAS, the SRC in its 409th meeting held on 29th 30th March 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution PSNL College of Education, Survey

- 6. NOW THEREFORE, this order is issued permitting the institution i.e. PSNL College of Education, Survey No. 483/1B, 485/1 & 487/2, Mettamalai Village, Mettamalai Panchayat, Sattur Taluka, Virudhunagar District, Tamilnadu-626203 run by Dr. P. Surulinarayanasami Educational & Charitable Trust, Virudhunagar District, TamilNadu for continuation of recognition for B.Ed. Programme with an annual intake of two years duration for (4 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
