WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely Shri Swamy College of Education for Women, No. 59/1B, Masinaickenpatti, Arothiyapattanam, NH-68, Salem District, Tamilnadu-636103 run by Sri Paspo Educational and Charitable Trust, Salem District, Tamilnadu vide order No. F.SRO/NCTE/B.Ed./2006-2007/13944 dated 01.11.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has 2. submitted affidavit on 28.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 24.02.2022. The institution has submitted reply on 21.03.2022.
- AND WHEREAS, the SRC in its 409th Meeting held on 29th & 30th March, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Swamy College of Education for Women, Survey No. 59/1, Masinaikanpatty Panchayat, Ayothiyapattanam, NH-68. Salem District. Tamilnadu-636103 for B.Ed. programme for 2 basic units of 50 students each."

- NOW THEREFORE, this order is issued permitting the institution i.e., Sri Swamy College Masinaikanpatty 59/1, Education for Women. Survey No. Ayothiyapattanam, NH-68, Salem District, Tamilnadu-636103 run by Swaminathan Saraswathi Educational Trust, Survey No. 59/1, Masinaikanpatty Panchayat, Ayothiyapattanam, NH-68, Salem District, Tamilnadu-636103 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available the list of students admitted on its official website.
- 11. The institution shall fill the information on GIS Portal on the NCTE Website.
