#### **ORDER**

WHEREAS, the recognition was granted to the institution namely Krishna College of Education, Khasara No. 114/2B, 114/1E2, 92/3A, 92/3B, Street No. 01, Plot No. 114, Meyyur Village and Post Office, Tiruvannamalai City and Taluk, Tiruvannamalai District - 606753, Tamilnadu was granted recognition vide SRC (NCTE) order no. F. No. SRCAPP1956/B.Ed/TN/2012 / 55982 dt. 07.01.2014 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulation 2014 the institution has submitted affidavit dt.30.01.2015 for its willingness of two units in B.Ed. course and adherence of provision of new Regulation. Thereafter revised provisional recognition order was issued to the institution on 18.03.2015 for conducting B.Ed course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued on 16.09.2019. The institution has submitted its reply on 15.10.2019 in respect of Show Cause Notice. The matter was placed before the SRC in its meeting 383<sup>rd</sup> held on 07<sup>th</sup> to 09<sup>th</sup> January, 2020 the Committee was decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 21.01.2020. The institution submitted its reply along with documents dt.02.03.2020. The reply was present before the Committee in its 385th meeting held on 03rd March 2020. The Committee considered the reply and decided to ask for latest staff list duly approved by the affiliating university. Accordingly, a letter was sent directing institution for submitting the latest staff list duly approved by the affiliating university on 06.03.2020. The institution has submitted its reply a latest staff list duly approved by the Registrar on 12.03.2020 of affiliating university.
- AND WHEREAS, the complicate submitted by the institution was considered by the SRC in its 386th meeting held on 23td & 24th July 2020 and committed decided as under: -

On the perusal of the records and original file, the letter dt. 12.03.2020 submitted by the Institution, Committee decided that the continuation order be issued to the Institution Krishna College of Education, Khasara No. 114/2B, 114/1E2, 92/3A, 92/3B, Street No. 01, Plot No. 114, Meyyur Village and Post Office, Tiruvannamalai City and Taluk, Tiruvannamalai District - 606753, Tamilnadu for B.Ed programme for 2 basic units of 50 students each.

- 5. NOW THEREFORE, this order is issued permitting the institution Krishna College of Education, Khasara No. 114/2B, 114/1E2, 92/3A, 92/3B, Street No. 01, Plot No. 114, Meyyur Village and Post Office, Tiruvannamalai City and Taluk, Tiruvannamalai District 606753, Tamilnadu for B.Ed programme for 2 basic units of 50 students each subject to fulfilment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available the list of students admitted on its official website.
- 11. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
