#### **ORDER**

WHEREAS, the recognition was granted to the institution namely SJES Teacher Education Institution, S.J.E.S Campus, Old Madras Road, Virgo Nagar Post, Bangalore-49, Karnataka run by Sri Jayachamarajendra Educational Society, Old Madras Road, Bangalore- 560049, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed/2008-09/4373 dated 30.8.2008 for conducting M.Ed. course of one-year duration with an annual intake of 25 students.

- 2. AND WHEREAS, vide order no. F.SRO/NCTE/2010-2011/20544 dated 28.08.2010 was issued to the institution for enhancement in intake of 10 seats from existing 25 to 35.
- 3. AND WHEREAS, the matter was considered in 233<sup>rd</sup> Meeting of SRC held on 26<sup>th</sup>-28<sup>th</sup> Sept, 2012 and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 19.11.2012. the institution did not submit reply of SCN.
- **4. AND WHEREAS,** the matter was considered in 242<sup>nd</sup> Meeting of SRC held on 14<sup>th</sup>-16<sup>th</sup> April, 2013 and decided to withdraw the M.Ed Course. Accordingly a Withdrawal Order was issued to the institution vide order no. F.No/APSO7342/M.Ed/KA/2013-14/51699 dt. 16.05.2013.
- **6. AND WHEREAS,** the institution submitted vide letter dt. 09.05.2014 received in this office on 23.05.2014 informed that Hon'ble High Court of Karnataka quashed the impugned order.
- 7. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 30.05.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-16.
- 8. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the Committee decided that Show Notice be issued to all such institutions which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on 04.02.2019. The matter was considered by the SRC in its 381<sup>st</sup> meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> Nov, 2019 and decided to issue Final SCN. Accordingly, as per the decision of SRC a

Final Show Cause Notice was issued to the institution on 11.12.2019. The institution vide letter dated nil received on 04.06.2020 submitted its reply to the Final Show Cause Notice.

**10. AND WHEREAS,** the SRC in its 386<sup>th</sup> meeting held on 23<sup>rd</sup> & 24<sup>th</sup> July, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the records and original file, the letter dt. 4.6.2020 submitted by the Institution, Committee decided that the continuation order be issued to the Institution SJES College of Education, Madahalli Old Madras Road, Bangalore- 560049, Karnataka for M.Ed programme for 1 basic unit of 50 students.

- 11. NOW THEREFORE, this order is issued permitting the institution i.e. SJES College of Education, Sy. No. 118, Old Madras Road, Medahalli, Virgonagar Post, Bangalore-560049, Karnataka run by Sri Jayachamarajendra Educational Society, Sy. No. 118, Old Madras Road, Medahalli, Bangalore-560049, Karnataka for continuation of recognition for M.Ed course of two years duration with an intake of 50 students (1 basic unit) of subject to fulfillment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and

laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
