#### **ORDER**

WHEREAS, the recognition was granted to the institution namely Sri Gowthami College of Education, Podili Road, Darsi, Prakasam District-523247, Andhra Pradesh run by Sri Gowthami Urban and Rural Integrated Development Educational Society, Darsi, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/APS07013/B.Ed/2006-2007/688 dt. 12.04.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, the matter was considered by SRC in its 167th meeting held on 14th -18th November 2008. The SRC after careful consideration of all aspects decided to conduct inspection under section 17 of NCTE Act 1993 for the teacher education institutions located at Podili Village. The inspection of the institution under section 17 was conducted on 22.12.2008.
- AND WHEREAS, the VTR was placed before SRC in its 170th meeting held on 16th -17th February 2009. The SRC considered the matter and decided to examine the whole matter by deputing an expert team consisting of SRC members.
- AND WHEREAS, the SRC in its 171 meeting held on 16th 17th March 2009 on perusal of Visiting Team/Expert Committee Report etc. decided to issue SCN to the institution.. Accordingly, a show cause notice was issued to the institution on 04.04.2009.
- AND WHEREAS, the SRC in its 177th meeting held on 27th -28th May 2009 observed that the deficiencies mentioned in the show cause notice were rectified and hence decided to continue the recognition accorded to the institution. Accordingly, a letter was sent to institution on 25.06.2009.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is 6. submitted affidavit dated 24.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS as per the decision 369th Meeting of SRC held on 28.01.2019 a Show Cause Notice to be issue to all such institution which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on 25.06.2019. The institution did not submit reply of show cause notice till date.
- 8. AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov. 2019 decided to issue Show Cause Notice to all such institution where compliance/representation has not been submitted by the institution. Accordingly, as per the decision of SRC a Final show cause notice

was issued to the institution on 29.11.2019. The institutions vide letter dated nil received on 05.02.2020 submitted reply to the alongwith land & building documents having address as S.No. 821/3 & 821/4, Darsi Village & Post Mandal, Prakasam District-523247, Andhra Pradesh and staff list etc.

**9. AND WHEREAS,** the SRC in its 387<sup>th</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> August, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 05.02.2020. Committee decided that the continuation order be issued to the Institution Sri Gowthami College of Education, Prakasam District-523247, Andhra Pradesh for B.Ed programme for 2 basic units of 50 students each.

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Gowthami College of Education, S.No. 821/3 & 821/4, Darsi Village & Post Mandal, Prakasam District-523247, Andhra Pradesh run by Sri Gowthami Urban and Rural Integrated Development Educational Society, Darsi, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-
  - I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III.The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of

the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
- e. Fee charged from students;
- f. Available infrastructural facilities:
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
