ORDER

WHEREAS, the institution namely Sri Krishna College of Education, Sri Krishna Nagar, Kainoor Village, Tiruttani Road, Arakkonam Taluk, Vellore District, Tamilnadu – 631003 run by Rural Welfare Trust, Tiruttani Road, Arakkonam-631003, Vellore District, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/ 8757 dt.26.10.2006 for conducting Secondary(B.Ed.) course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 08.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, revised provisional recognition order was issued to the institution on 01.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision a Show Cause Notice was issued to the institution on 14.03.2019. The institution submitted its reply along with documents on dt. 16.04.2019 vide letter dated 08.04.2019 & 10.04.2019.

AND WHEREAS, the above matter was put before the SRC in its 382nd meeting held on 26th -27th November 2019 and the Committee considered the matter and decided to issue Final Show Cause Notice.

AND WHEREAS, as per the decision a Show Cause Notice was issued to the institution on 09.12.2019. The institution submitted its reply along with documents on dt. 30.12.2019 vide letter dated 25.12.2019.

WHEREAS, the institution namely Sri Krishna College of Education, Sri Krishna Nagar, Kainoor Village, Tiruttani Road, Arakkonam Taluk, Vellore District, Tamilnadu – 631003 run by Rural Welfare Trust, Tiruttani Road, Arakkonam-631003, Vellore District, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed-AI/2006-2007/ 1714 dt.16.05.2008 for conducting B.Ed (Additional Intake) course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 08.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, revised provisional recognition order was issued to

the institution on 01.05.2015 for conducting B.Ed-AI of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the institution submitted compliance against RPRO matter on dt. 02.11.2015. Thereafter, the matter was placed before in 314th meeting of SRC held on 27th & 28th May 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, inspection of the institution was conducted on 09.11.2016.

AND WHEREAS, the complicate submitted by the institution was considered by the SRC in its 383rd meeting held on 07th to 09th January, 2020 and committed decided as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

On the perusal of the original documents and records submitted by the institution in respect of Final Show Cause Notice. The Committee decided that the continuation order be issued to Sri Krishna College of Education, Sri Krishna Nagar, Kainoor Village, tiruttani road, Arakkonam Taluk, Vellore District, Tamilnadu – 631003 for B.Ed programme for 4 basic units (50 students each).

NOW THEREFORE, this order is issued permitting the institution Sri Krishna College of Education, Sri Krishna Nagar, Kainoor Village, Tiruttani Road, Arakkonam Taluk, Vellore District, Tamilnadu – 631003 run by Rural Welfare Trust, Tiruttani Road, Arakkonam-631003, Vellore District, Tamilnadu for continuation of conducting B.Ed course of two years duration with an intake of 200 students (four units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

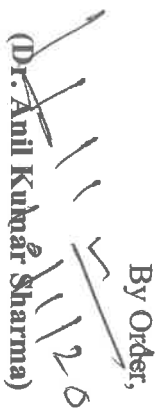
- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

The institution shall make available the list of students admitted on its official website.

The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

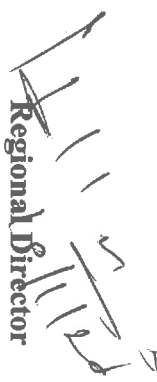
