# WITHDRAWAL ORDER

WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Adarsha Institute of Elementary Teacher Education, Khasara No.454/e/1, 454/e/3, 454/e/4, Adarsha Hills Street, Narayanpet Village and Post Office, Narayanpet taluk and city, Mahbubnagar District-509210, Andhra Pradesh run by Adarsha Educational Society, Plot No.1-5-30/4, Adarsha Hills Street, Narayanpet Village and Post Office, Narayanpet taluk and city, Mahbubnagar District-509210, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/SRCAPP920/D.EI.Ed./AP/2015/62281 dated 03.03.2015 for conducting D.EI.Ed. Course of two years duration with an annual intake of 50 students from the academic session 2015-2016.

- 2. AND WHEREAS, the SRC in its 412<sup>th</sup> meeting held on  $05^{th}-06^{th}$  July 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. As per decision of SRC, Show Cause Notice was issued to the institution on 03.08.2022. The management of the institution did not submit any reply to the Show Cause Notice.
- **3. AND WHEREAS,** a letter dated 19.08.2022 has submitted by the management of the institution for closure of D.El.Ed. Programme.
- **4. AND WHEREAS**, the SRC in its 418<sup>th</sup> Meeting of SRC held on 16<sup>th</sup> December 2022 considered the matter for closure of the D.El.Ed. Programme and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 19.08.2022 by withdrawing the recognition granted to Adarsha Institute of Elementary Teacher Education, Khasara No.454/e/1, 454/e/3, 454/e/4, Adarsha Hills Street, Narayanpet Village and Post Office, Narayanpet taluk and city, Mahbubnagar District-509210, Telangana for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session, 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting".

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Adarsha Institute of Elementary Teacher Education, Khasara No.454/e/1, 454/e/3, 454/e/4, Adarsha Hills Street, Narayanpet Village and Post Office, Narayanpet taluk and city, Mahbubnagar District-509210, Telangana for conducting D.El.Ed. Programme of two years duration with an annual intake of 50 students with effect from the academic session i.e. 2022-2023 onwards.
- **6.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
