WHEREAS, the recognition was granted to the institution namely Mother Teresa College of Education, Khammam District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/166/SRO/NCTE/2002-2003/6684 dt 08.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WITEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 10.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the institution had submitted written representation on 12.05.2015 and 03.11.2015. The documents were processed and agenda placed before SRC in its 315th meeting held on 17th -18th June 2016, and the Committee considered the matter and decided to constitute VT. Accordingly, as per the decision of SRC a inspection intimation was sent to institution on 12.07.2016. The inspection of the institution was conducted on 18.08.2016 and the VT report received in the office on 24.08.2016.

AND WHEREAS, the SRC in its 321st meeting held on 28th – 30th September, 2016 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 24.10.2016. The institution vide letter dated 10.11.2016 submitted reply to the Show Cause Notice.

AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Further, the RD is authorized to issue Final Show Cause Notice and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on 21.11.2019. The institution vide letter dated 21.12.2019 submitted its reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 389th Meeting held on 12th & 14th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice dt. 21.11.2019. In response the institution submitted reply vide its letter dt. 21.12.2019 alongwith documents but the following deficiencies were observed:-

1. The institution has not submitted notarized English version of the LUC is not submitted.

2. The institution has submitted photocopy of building plan in which site area & multipurpose hall area are not mentioned as well as not approved by the competent

authority.

3. The institution submitted photocopy of letter dt 25.10.2019, 18.01.2019, 21.09.2017, 19.06.2016 and 17.05.2013 list of faculty approved by the Registrar, Kakatiya University. However, the institution has not submitted latest list of faculty under prescribed format.

4. The institution is required to submit a Form A issued by the respective Bank Manager towards creation of FDR of Rs 7 Lakh and 5 lakh totalling Rs 12 lakh

towards Endowment and Reserve Fund under NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to Mother Teresa College of Education, Palavancha Revenue Division, New Paloncha, Khammam District-507115, Telangana for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Mother Teresa College of Education, Palavancha Revenue Division, New Paloncha, Khammam District-507115, Telangana for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
