ORDER

WHEREAS, the recognition was granted to the institution namely **Mother Teresa College of Education, Khammam DT, Andhra Pradesh** vide SRC (NCTE) order no. F.AP/NEW/B.Ed/166/SRO/NCTE/2002-2003/6684 dt. 08.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students of one-year duration from the academic session 2002-2003.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 10.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the documents were processed and agenda placed before SRC in its 315th meeting held on 17th -18th June 2016, and the Committee considered the matter and decided Collect, balance of the 'Fee' and cause inspection. Accordingly as per the decision of SRC, the inspection intimation was sent to institution on 12.07.2016. The inspection of the institution was conducted on 18.08.2016 and the VT report received in the office on 24.08.2016 along with shifting inspection fee of Rs. 1,10,000.

4. **AND WHEREAS**, the SRC in 381st meeting held on 31st Oct & 1st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice was issued to the institution on 21.11.2019. The institution vide letter dated 21.12.2019 submitted its reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided to issue withdrawal order. Accordingly, as per the decision of SRC withdrawal order was issued to the institution on 21.10.2020.

6. **AND WHEREAS**, the institution represented its case and sent an e-mail on 27.10.2020, 02.11.2020 and the same was considered by the SRC in its 391st meeting held on 3rd November, 2020. The Committee after consideration of the representation submitted by the institution decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **Mother Teresa College of Education, Palavancha Revenue Division, New Paloncha, Khammam District-507115, Telangana** for B.Ed programme for 2 basic units of 50 students each unit.

7. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Mother Teresa College of Education, Sy.No. 82/3/A,83/2, Ward & H.No:-23-2-1/2. Srinivasa Colony, Paloncha Municipality, Khammam District-507115, Telangana** run by **Boon Education Environment & Rural Development Society, Paloncha, Khammam District-507115, Telangana** for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-

I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III.The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV.The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

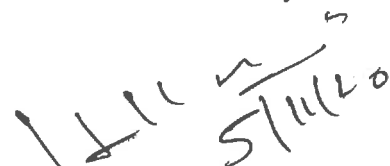
12. The institution shall make available the list of students admitted on its official website.

13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
