WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely MNR Elementary Teacher Education College, Sangareddy, Medak District, Andhra Pradesh run by MNR Educational Trust, Srivani Nagar, Kukatpally, Hyderabad – 500072, Telangana vide SRC (NCTE) order F.SRC/NCTE/APS02897/D.Ed/2005-2006/2595 dated 28.06.2005 for conducting D.Ed course of two-year duration with an annual intake of 50 students.

AND WHEREAS, the institution vide letter dated 19.09.2020 submitted written representation. The SRC in its 389th meeting held during 12th – 14th October, 2020 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to MNR Elementary Teacher Education College, Sangareddy, Medak District, Telangana for conducting D.Ed course under clause 17(1) of NCTE Act, 1993 on its own request made vide letter dated 19.09.2020. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of MNR Elementary Teacher Education College, Sangareddy, Medak District, Telangana for conducting D.Ed programme of two years duration with an annual intake of 50 students (1 unit) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an Institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such Institution, shall not be treated as a valid qualification for
