AND WHEREAS, the recognition was granted to the institution namely MNR Elementary Teacher Education College, Bachupally, Kukatpally, Hyderabad-500072, Andhra Pradesh run by MNR Educational Trust, Kukatpally, Hyderabad-500072, Andhra Pradesh The SRC vide order F.SRC/NCTE/D.Ed/2005-2006/2528 dt.26.08.2005 for conducting (D.Ed) course of two-year duration from the academic session 2005-06 with an annual intake of 50 students.

- 2. AND WHEREAS, a letter is received from the Director of School Education Government of Telangana Hyderabad Lr.No.16/N1-3/2014 dated 06.05.2015.
- 3. AND WHEREAS, the SRC in its 290th Meeting held on 10th & 11th July 2015, considered the matter, letter from the Director School Education Department, Telangana State and decided to issue Show Cause Notice to the institution for withdrawal of recognition of submission of fake fire certificate by the college. Accordingly, a show cause notice was issued to the institution on 04.09.2015. The institution has submitted written representation on 25.09.2015.
- 4. AND WHEREAS, the SRC in its 289th Meeting held on 23rd June, 2015 considered the letter dated 16.03.2015 from Director of School Education, Govt. of Telangana, Hyderabad, in respect of certain private Diploma in Elementary Teacher Education Colleges (43 Colleges) not fulfilling the deficiencies and decided to issue show cause notice. A show cause notice was issued to the institution on 16.09.2015 for B.Ed, D.Ed & M.Ed course. The institution has submitted its written representation on 13.10.2015.
- 5. AND WHEREAS, the replies submitted by 15 colleges were placed before SRC in its 294th Meeting held on 14th -16th November 2015, 295th meeting held on 28th -30th November, 2015 and the Committee decided as under:-
 - 1. Reply is satisfactory. It is accepted.
 - 2. Inform the affiliating body concerned.
 - 3. Close the case.
- 6. AND WHEREAS, a letter was issued to the Director of School Education for grant of renewal of temporary provisional for the year 2014-15 on 04.02.2016. The institution vide letter dated 14.07.2020 submission of closing Institution.

7. AND WHEREAS, the matter was further considered by the SRC in its 390th meeting held on October 28-29, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to MNR Elementary Teacher Education College, Bachupally, Kukatpally, Hyderabad-500072, Telangana for conducting D.El.Ed course under clause 17(1) of NCTE Act, 1993 on its own request made vide letter dated 14.07.2020. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course.
- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to MNR Elementary Teacher Education College, Bachupally, Kukatpally, Hyderabad-500072, Telangana run by MNR Educational Trust, Kukatpally, Hyderabad-500072, Telangana for conducting D.El.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- 9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day falls or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
