AND WHEREAS, the recognition was granted to the institution namely Sree Rama College of Education, Sreenivasapuram, Tiruchanoor Road, Tirupathi-517503, Chittoor District, run by Sree Rama Educational Society, Sreenivasapuram, Andhra Pradesh Tiruchanoor Road, Tirupathi-517503, Chittoor District, Andhra Pradesh .The SRC vide order No.F.AP/B.Ed-91/SRO/NCTE/2000-2001/9058 dt.28.04.2005 for conducting (B.Ed.) course of two-year duration from the academic session 2004-05 with an annual intake of 160 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by 2. consented to come under new Regulations vide a notarized affidavit dated 19.01.2015. A Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 28.02.2019. The institution has not submitted any reply to Show Cause Notice.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on 20.11.2019.
- AND WHEREAS, the institution submitted its reply to the Final Show Cause Notice vide letter dated 09.12.2019.
- AND WHEREAS, the matter was further considered by the SRC in its 390th meeting held on October 28-29, 2020 and the Committee decided as follows: -

furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) The institution has submitted its reply on 09.12.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted notarized copy of Land Document, but certified copy is not submitted.
  - (i) There is variation in survey No. between Land Document submitted at the time of Recognition in which survey No. mentioned as 198/5, 6b, 8, 208/11, 207/9, 207/9, 207/7 and now submitted Land Document bearing survey 242.
- 2. The institution has submitted notarized copy of Site plan but not approved by competent authority.
  - (i) Site area not mentioned
  - (ii) Survey No. not mentioned
- 3. The institution has failed to submit latest copy of Faculty list as per NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to Sree Rama College of Education, Sreenivasapuram, Tiruchanoor Road, Tirupathi-517503, Chittoor District, Andhra Pradesh for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sree Rama College of Education, Sreenivasapuram, Tiruchanoor Road, Tirupathi-517503, Chittoor District, Andhra Pradesh run by Sree Rama Educational Society, Sreenivasapuram, Tiruchanoor Road, Tirupathi-517503, Chittoor District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day falls or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of

employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
