WHEREAS, the recognition was granted to the institution namely Sri Chaitanya College of Education, Opp. APSRTC Bus Stand, Viswanathapuram, Podili, Prakasham District -523240, Andhra Pradesh run by Chaitanya Educational Society, Prakasam District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/SEC/N/SRO/NCTE/2005-2006/5592 dated 09.03.2006 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, the inspection of the institution under section 17 was conducted on 24.12.2008, the VTR was placed before SRC in its 171st meeting held on 16th - 17 March 2009 and SRC decided to issue show cause notice. Accordingly, as per the decision of SRC show cause notice was issued to the institution on 04.04.2009. The institution has submitted its written representations on 27.04.2009.
- 3. AND WHEREAS, the letter dated 18.06.2009 has been placed on the table of the committee in its 177th meeting held on 22nd -23nd June 2009 considered the matter and decided to issue withdrawal order. Accordingly, as per decision of SRC withdrawal order no. F.SRO/NCTE/APSO4439/2009-10/14519 dated 13.07.2009 was issue to the institution.
- 4. AND WHEREAS, aggrieved by the withdrawal order of SRC, the institution preferred an appeal to NCTE-Hgrs. NCTE, Hgrs. vide order. F.No. 89-1241/2009-Appeal dated 12.02.2010 the Council hereby remands back the case. The above appellate authority order was placed before SRC in its 189th meeting held on 25th -26th February, 2010 and the committee decided to cause re-inspection. Accordingly, as per the decision of SRC a letter was issued to the institution on 04.03.2009.

- 5. AND WHEREAS, the SRC in its 270th meeting held on 13th July 2014 considered the matter appellate authority order and decided to cause inspection. As per the decision of SRC a letter was prepared but was kept pending due to the order of the Hon'ble Supreme Court order dated 10.09.2013.
- 6. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 03.01.2015

- 7. AND WHEREAS, as per the decision of SRC a inspection letter was issued to the institution on 28.01.2015. The inspection of your institution for B.Ed. & D.El.Ed. course will be carried out by a team of experts during 23rd 27th March, 2015.
 - 8. AND WHEREAS, the SRC permitted the institution to shift the premises to the new location/building at Sri Chaitanya College of Education, Sy. No. 717, Podili Village, Podili Mandal, Prakasam District, Andhra Pradesh.
 - 9. AND WHEREAS, a revised provisional recognition order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
 - 10. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01,2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance Accordingly, Show Cause Notice issued on 30.04.2019. The institution vide letter dated 27.05.2019 submitted reply to the show cause notice.
 - 11. AND WHEREAS, the SRC in its 379th meeting held on 21st 22nd August, 2019 considered the matter and decided to issued Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice issued on 29.08.2019. The institutions vide letter dated 19.09.2019 submitted reply to the Final Show Cause Notice.
 - 12. AND WHEREAS, the SRC in its 388th meeting held on 14th to 15th September, 2020 considered the matter decided as under:-

Regulations Guidelines issued by NCTE from time to time and documents furnished by the following observations were made:-

The Committee decided to write a letter to the Institution asking therein to submit the following documents: -

In view of the above, the Committee decided to seek the above documents from the Institution by sending a last reminder (Letter) before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents / representation mentioned above within 30 days from the date of issue of the letter.

13. AND WHEREAS, as per the decision of SRC a last reminder letter was issued to institution on 24.09.2020. The institution vide letter dated 08.10.2020 submitted its reply to the alongwith land & building documents having address as Sy.No. 717, Ongole Road, Podili (panchayat), Podili (mandal), Prakasam District- 523240 Andhra Pradesh and staff list etc.

14. AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 19.09.2019, the Committee decided that the continuation order be issued to the Institution Sri Chaitanya College of Education, Prakasam District, Andhra Pradesh for B.Ed programme for 2 basic unit of 50 students each.

- 15. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Chaitanya College of Education, Sy.No. 717, Ongole Road, Podili (panchayat), Podili (mandal), Prakasam District- 523240 Andhra Pradesh run by Chaitanya Educational Society, Markapur-523316, Prakasam District, Andhra Pradesh for continuation of recognition for B.Ed. course of two years duration with an intake of 100 students (2 units) of subject to fulfillment of the following conditions:-
 - I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - seemed and the Institution shall ensure that the required number of academic staff duly approved the possible by affiliating body for conducting the course should always remain in position.
 - 16. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
 - 17. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
 - 18. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with
