WHEREAS, the recognition was granted to the institution namely Sri Mandali Venkata Krishna Rao College of Education, Gandhia Kshetram, Avanigadda, Krishna District – 521121, Andhra Pradesh run by Gandhian United Action for Rural Development, Krishna District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/APS08968/B.Ed/2007-2008/13320 dt 23.10.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, the NCTE-Hqrs, new Delhi has forwarded a complaint dated nil received on 17.12.2012 made by 1. Sanaka Arjune Rao, 2. Ambati Laxmi 3. Mopidevi Sujan 4. K. Ravikanth. The complaints are stated that, Shortcoming / irregularities in three Colleges in respect of (i) SMVKR College of Education (ii) SMVKR College of D.Ed. and (iii) Dashina Bharath Hindi College, Post-Krishna, District, Andhra Pradesh.

AND WHEREAS, as per the decision of SRC, the comparative statement was placed before SRC in its 254^{th} meeting held on $25^{th}-27^{th}$ October, 2013 and the committee considered the VT repost, VCD of the institution and all the relevant documentary evidences and it was decided to serve Show cause Notice for both the cases (APS08964 & APS08968). Accordingly, as per the decision of SRC, Show Cause Notice was issued to the institution on 28.11.2013. the institution has submitted its written representation on 20.12.2013. The SRC in its 260th meeting held on $29^{th}-31^{st}$ January, 2014 considered the reply of the institution vide letter dated 20.12.2013 to the Show Cause Notice issued and other related documents, along with the original file of the institution and decided to continue recognition accorded to the institution for B.Ed (APS08968) course,

AND WHEREAS, the SRC recognition continues vide order no. F.No.APS08968/B.Ed /AP/2014-15/57024 dated 20.02.2014 was issued to the institution.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 19.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, as per RPRO vide order no. F.No/SRC/NCTE/APS08968/B.Ed/AP /2015/64020 dated 06.05.2015 on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.

AND WHEREAS, on the basis of request, the SRC in its 342nd meeting decided for reduction of intake from 2 units to 1 unit. Accordingly a order dated 08.9.2017 was issued to the institution.

AND WHEREAS, as per the decision 369th Meeting of SRC held on 28.01.2019 a Show Cause Notice to be issue to all such institution which have not submitted compliance. Accordingly, a

show cause notice was issued to the institution on 03.05.2019. The institution vide letter dated 04.04.2019 submitted its reply to the show cause notice.

AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov. 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents. As per the decision of SRC a final show cause notice was issued to the institution on 20.11.2019. The institution has submitted on 12.12.2019 submitted its reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 389th Meeting held on 12th & 14th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 20.11.2019. The institution has submitted its reply on 12.12.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted notarized copy of land documents i.e. "sale deed". However, the land documents is in favour / name of an individual which is not acceptable under NCTE Regulations, 2014.
- 2. The institution has submitted notarized copy of building plan. Whereas the name of the institution is mentioned as Sri Mandali Krishna Rao B.Ed and D.Ed College is different since at time of recognition order the name of the institution was mentioned as Sri Mandali Venkata Krishna Rao College of Education.
- 3. The total built-up area available with the institution is only 1619.48 sq.mts whereas the institution is running both course. Accordingly, the built-up area is not sufficient as required under NCTE Regulations, 2014.
- 4. A letter dated 02.05.2017 regarding term deposit issued by Brach manager, Indian Bank. The institution has not submitted "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.
- 5. The institution is not maintaining the website as required under NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to Sri Mandali Venkata Krishna Rao College of Education, Gandhia Kshetram, Avanigadda, Krishna District – 521121, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sri Mandali Venkata Krishna Rao College of Education, Gandhian Kshetram, Avanigadda, Krishna District – 521121,

Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of two years duration with an annual intake of two years.

Further, the institution and affiliating body is hereby informed about the following provision c

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website appeal may be seen on NCTE's website.
