WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely New Model College of Education, Siddavattam, Rajampetta Revenue Division, Kadapa District-516237, Andhra Pradesh vide order No. F. AP/NEW/B.Ed/SRO/NCTE/2004-2005/1485 dated 17.06.2005 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, on promulgation of NCTE-Regulations, 2014, the institution submitted affidavit dated 22.01.2023 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units of 50 students each) from the academic session 2015-16.
- AND WHEREAS, the institution was permitting to shift its premises to the new 3. location/building at New Model College of Elementary Education, Plot/Khasara No. 100/1, Thollagang Street, Thollaganganapalli Village and post office, Chennur Andhra Pradesh District-516162 Kadapa F.SRO/APSO3694/B.Ed/AP/2016/84374 dated 14.04.2016.
- AND WHEREAS, the SRC in 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 15.03.2019. The institution was not submitted reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 380th meeting held on 18th -19th September 2019 considered the matter and the Committee was decided to issue Final Show Cause Notice to all such institution where reply to the SCN had not been submitted by the institution. Accordingly a Final Show Cause Notice was issued to the institution on 11.10.2019. The institution was not submitted the reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 382nd meeting held on 26th & 27th November, considered the matter and decided to issue Withdraw the recognition of institution. Accordingly, a Withdrawal order No. SRO/NCTE/APS03694/B.Ed. AP/2019/12659-2665 was issued to the institution on 06.12.2019.

- AND WHEREAS, thereafter, the Institution has filed Writ Petition before Hon'ble High Court of Andhra Pradesh bearing W.P No.14951/2023 titled as Sri Sai Educational Society versus National Council for Teacher Education & others order dated 04.09.2023.the institution has submitted a representation on 18.09.2023, 21.09.23 and 03.10.2023 of the direction of Hon'ble High Court order dated 04.09.2023.
- AND WHEREAS, the SRC in its 429th meeting held on 11th October 2023 8. considered the matter and decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act 1993. Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-

In the obedience to the Hon'ble High Court of Andhra Pradesh at Amaravati order dated 04.09.2023 in W.P No. 14951 of 2023 titled Sri Sai Educational Society and others vs NCTE & others, the Committee decided to issue continuation order to the Institution i.e. New Model College of Education, Siddavattam, Rajampetta Revenue Division, Kadapa District-516237, Andhra Pradesh for B.Ed. programme for 2 basic units of 50 students each."

- NOW THEREFORE, this order is issued permitting the institution I.e. New Model of Education. Plot/Khasara No. 100/1, Thollagang Thollaganganapalli Village and post office, Chennur Taluk Kadapa District-516162 Andhra Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the III. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff duly IV. approved by affiliating body for conducting the course should always remain in position.

10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Mesermy Government etc. as applicable.

 - Available infrastructural facilities; f.
 - Facilities added during the last quarter; g.
 - Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - The affidavit with enclosure submitted along with application. i.
 - The institution shall be free to post additional relevant information if it so j. desires.
 - Any false or incomplete information on website shall render the institution k. liable for withdrawal of recognition.
