WITHDRAWAL ORDER

WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, **MNR College of Education, Fasalwadi, Sangareddy Mandal, Medak, Andhra Pradesh-502294** vide order no. F.SRO/NCTE/B.Ed./2007-2008/13321 dt. 23.10.2007 for conducting **B.Ed.** course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 23.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students for two basic units** from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 19.02.2019. The institution has submitted reply on 26.03.2019.

4. AND WHEREAS, the SRC in its 401st meeting held on 11st – 12nd August, 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 28.08.2021. The institution has submitted reply on 18.09.2021.

5. AND WHEREAS, the SRC in its 409th Meeting held on 29th & 30th March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 18.09.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The approvals over the building plan is not legible.**
- 2. The institution has not submitted the requisite documents regarding proof of disbursement of salary to faculty & non-teaching staff through bank account as per direction of the Appellate Authority, NCTE as required under clause 10(2) of NCTE Regulations, 2014.**
- 3. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.**
- 4. The institution did not submit registration, bye-laws etc. related to the managing society / trust.**

5. The institution failed in submission of latest approval of faculty issued by the affiliating University.

Hence the recognition granted to MNR College of Education, Fasalwadi Sangareddy Mandal, Medak District-502294, Telangana for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e., 2022-2023. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e., 2022-2023."

6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **MNR College of Education, Fasalwadi Sangareddy Mandal, Medak District, Telangana-502294** run by **MNR Educational Trust, Fasalwadi Sangareddy Mandal, Medak District, Telangana-502294** for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students (2 basic units)** with effect from the academic session i.e., 2022-2023 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., **2022-2023** and the institution is also not permitted to take any fresh admission of students from the academic session **2022-2023**.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
