WITHDRAWAL ORDER

WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, **Moghal College of Education, Hyderabad Revenue Division Bandlaguda Khalsa, Charminar Erstwhile Taluqa, Hyderabad District, Andhra Pradesh for B.Ed.& B.Ed.-AI programmes:-**

- (i) The SRC vide Order No. F.AP/NEW/B.Ed./177/SRO/NCTE/2002-2003/6135 dated 28.02.2003 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.
- (ii) The SRC vide order No. F.SRO/NCTE/APS07232/B.Ed.-AI/TN/2007-2008/14306 dated 07.11.2007 for conducting B.Ed. (Additional Intake) programme of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated **22.01.2015**. A provisional revised recognition order was issued on 27.04.2015 to the institution for conducting **B.Ed. & B.Ed.-AI programme** of two years duration with an annual intake of **100 students & 100 students (two basic units) total 4 basic units** from the academic session 2015-16.

3. **AND WHEREAS**, a corrigendum order was issued to the institution vide order no. F.SRO/NCTE/APS07232/B.Ed.-AI/AP/2015/70542 dt. 22.07.2015 for conducting B.Ed. programme of two years duration with an **annual intake of 200 for four basic units** from the academic session 2015-2016.

4. **AND WHEREAS**, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per the decision of SRC, a First Show Cause Notice was issued to the institution on 19.11.2019. The institution has submitted a reply on 16.12.2019.

5. **AND WHEREAS**, the SRC in its 400th meeting held on 13th – 14th July 2021 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 03.08.2021. The institution has submitted a reply on 02.09.2021.

6. **AND WHEREAS**, the SRC in its 409th Meeting of SRC held on 29th – 30th March 2022 considered the matter and decided as under: -



"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 02.09.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution did not submit a Latest approval of faculty issued by the affiliating body.**
- 2. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.**

*Hence the recognition granted to **Moghal College of Education, D. No. 8-5-2/18, Bandlaguda, Near Chandrayanagutta, Hyderabad, Telangana – 500005** for **B.Ed. & additional intake in B.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e., **2022-2023**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the next academic session i.e., **2022-2023**".*

7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition **Moghal College of Education, D. No. 8-5-2/18, Bandlaguda, Near Chandrayanagutta, Hyderabad, Telangana – 500005** run by **Moghal Educational Society, Hyderabad-500005, Telangana** for conducting **B.Ed. & B.Ed.-AI Programme** of two years duration with an annual intake of **200 students (Four basic units)** with effect from the academic session i.e., **2022-2023** onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., **2022-2023** and the institution is also not permitted to take any fresh admission of students from the academic session **2022-2023**.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University,

or in any school, College or other Educational Body aided by the Central Government or any State Government.”

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
