WHEREAS, the permission u/s15 Act of NCTE, 1993 was granted to the institution namely, Keins Teacher Training Institute, 139, Asir Nagar, (Via), Thalapathy Samuthram-627103, Thirunelveli District, TamilNadu for D.T.Ed. & D.T.Ed.-Al Courses: -

- (i) The SRC vide Order No.F.TN/750/SRO/NCTE/2004-05/6808 dated 09.09.2004 for conducting Elementary Course of two-years duration with an annual intake of 50 students from the academic session 2004-2005.
- (ii) The SRC vide order No. F.SRO/NCTE/D.T.Ed.-A.I./2006-2007/9189 dated 13.11.2006 for conducting Elementary D.T.Ed.(Additional Intake) course of two-years duration with an annual intake of 50 students.
- AND WHEREAS, the institution vide letter dated 16.03.2022 has submitted request to close the D.T.Ed. & D.T.Ed.-Al Programme.
- AND WHEREAS, the SRC in its 409th Meeting of SRC held on 29th 30th March 2022 considered the request for close the D.T.Ed. & D.T.Ed-Al Programme and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution vide dated 16.03.2022 by withdrawing the recognition granted to Keins Teacher Training Institute, 139, Asir Nagar, (Via), ThalapathySamuthram, Thirunelveli District, Tamilnadu-627103 for conducting D.T.Ed. alongwith additional Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting".

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition Keins Teacher Training Institute, 139, Asir Nagar, (Via), ThalapathySamuthram, Thirunelveli District, Tamilnadu-627103 run by Ken-A-Z Educational and Industrial Society, Thirunelveli District, Tamilnadu-627103 for conducting D.T.Ed. & D.T.Ed.-A.I. Course of two years duration with an annual intake of 100 students with effect from the academic session i.e., 2022-2023 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
