WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely Shri Balaji College of Education, Arcot Road, Irumbedu Arni Taluk, Thiruvannamalai, Tamilnadu-632317 run by Tmt. Kannammal Education Trust, No. 1221, G.N. Chetty Road, T.Nagar, Channai-600017, Tamilnadu for conducting B.Ed., B.Ed.-Al Courses:-

- (i) The SRC vide order No. F.TN/SEC/NCTE/2005-2006/5283 dated 31.09.2006 to offer Secondary (B.Ed.) course of one year duration from the academic session 2005-06 with the annual intake of 100 students.
- (ii) The SRC vide order No. F.SRO/NCTE/SRCAPP1844/B.Ed-Al/TN/2015/62186 dated 03.03.2015 for conducting B.Ed-Al programme of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 07.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 01.05.2015 for conducting B.Ed. & B.Ed.-Al Programme of two years duration with an annual intake of 100 + 100 (four basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its  $388^{th}$  meeting held on  $14^{th}-15^{th}$  September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 08.06.2021. The institution has submitted reply on 25.06.2021.
- **4. AND WHEREAS,** the SRC in its 401<sup>st</sup> Meeting held on 11<sup>th</sup> -12<sup>th</sup> August 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 31.08.2021. The institution has submitted reply on 20.09.2021.
- **5. AND WHEREAS,** the SRC in its 409<sup>th</sup> Meeting held on 29<sup>th</sup> -30<sup>th</sup> March 2022 considered the matter and decided as under:-

furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 20.09.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution submitted approvals of faculty (one Principal, 2 Professors, 2 Associate Professors, 19 Assistant Professors, 1 Physical director, 1 faculty for fine arts; Total 26). The institution also failed to submit supporting documents in terms of educational qualification of the faculty and experience certificate of the Principal. The faculty strength is not sufficient for B.Ed. (4 units) and M.Ed. (1 unit).
- 2. The institution did not submit the bank statement showing disbursement of salary to faculty through bank account as stipulated under clause 10(2) of NCTE Regulations, 2014.
- 3. The institution did not appoint faculty for Performing Arts.

Hence, the Committee decided to withdraw the recognition granted to Shri Balaji College of Education, Arcot Road, IrumbeduArni Taluk, Thiruvannamalai, Tamilnadu-632317 for conducting <u>B.Ed., B.Ed-Al & M.Ed.</u> programmes with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

6. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Shri Balaji College of Education, Arcot Road, IrumbeduArni Taluk, Thiruvannamalai, Tamilnadu-632317 for conducting B.Ed. & B.Ed-Al programme of two year duration with an annual intake of 200 students (four basic units) for B.Ed. course with effect from the academic session i.e. 2022-2033 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or

University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
