WHEREAS, the recognition was granted to the institution namely, Lal Bahadur College of Education, SVP Road, Warangal District, Andhra Pradesh-506007 run by Osmania Graduates Association and Exhibition Society, Warangal District, Andhra Pradesh vide SRC vide order no. F.SRO/NCTE/M.Ed./2007-2008/2041 dt. 05.06.2008 for conducting M.Ed. course of one year duration with an annual intake of 25 (twenty five) students.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to Lal Bahadur College of Education, SVP Road, Warangal District, Andhra Pradesh-506007 vide order No. F.SRO/NCTE/2010-2011/20629 dt. 24.08.2010from the session 2010-2011.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 23.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 19.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students for one basic unit from the academic session 2015-16.
- **4. AND WHEREAS,** the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 25.11.2019. The institution has submitted reply on 17.12.2019.
- **5. AND WHEREAS,** the institution has submitted a written representation vide letter dt. 24.06.2021 for request for close the M.Ed. Programme.
- 6. AND WHEREAS, the SRC in its 409th Meeting held on 29th & 30th March, 2022 considered the request for close the M.Ed. Programme and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution vide dated 24.06.2021 by withdrawing the recognition granted to **L.B. College of Education, Warangal Revenue Division, S.P. Road, Warangal District-506007 Telangana** for conducting **M.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to L.B. College of Education, Survey No. 757, 758, 759, 761, 837, 837, 838, 25A-14G, Rangampet, Warangal Revenue Division, S.P. Road, Warangal District, Telangana 506007 run by Osmania Gradute's Association & Exhibition Society, Survey No. 757, 758, 759, 761, 837, 838, 25A-14G, Rangampet, Warangal Revenue Division, S.P. Road, Warangal District, Telangana-506007 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
