WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, G.M.R. College of Education, G.M.R. Complex Main Road, Tadepalligudem, West Godavari, Andhra Pradesh vide order no. F.SRO/NCTE/B.Ed./2007-2008/11441 dt.17.09.2007 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 17.01.2015. A provisional revised recognition order was issued on 26.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, an order No.F.SRO/NCTE/APS08568/B.Ed./A.P./2015-16/85695 was issued to the institution on 26.05.2016 for shifting of premises at new location/building i.e. G.M.R. College of Education, Plot/Khasara No.414/1C, Street No.1, Tadepalli Village & Post, Tadepalligudem Taluk & City, West Godavari District-534101, Andhra Pradesh.
- 4. AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, a Show Cause Notice was issued to the institution on 25.04.2019. The institution has submitted a reply on 13.05.2019.
- 5. AND WHEREAS, the SRC in its 405th meeting held on 13th 14th December 2021 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 27.12.2021. The institution has submitted a reply on 05.01.2022.
- 6. AND WHEREAS, the SRC in its 409^{th} Meeting of SRC held on $29^{th}-30^{th}$ March 2022 considered the reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 05.01.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution submitted a proforma of Faculty signed by the Registrar, A.N. University but the date of approval has not been mentioned.
- 2. Eight faculty namely, Himabindu Pitta, SubbalaxmiKumpatla, RajeshkumarAmalapurapu, VenkataraoPasalapudi, Trinadha Prasad Alanka, Palleti NG Kishore Kumar, Prasanthi Kumari Y, Dr.Boddu Sudha Priya are not NET qualified and appointed after 09.06.2017, hence, not eligible for appointment as per NCTE Regulations, 2014 (amended vide notification dated 09.06.2017).
- 3. The institution submitted a proforma of 16 faculty for D.El.Ed. Course signed by the Director, SCERT on 04.03.2011. The institution failed in submission of latest faculty issued by the SCERT.
- 4. The building plan submitted by the institution do not show whether the building is roofed by RCC or not.
- 5. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.
- 6. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account for last one year as required under clause 10(2) of NCTE Regulations, 2014.
- 7. The institution did not submit registration certificate and bye laws of the managing society / trust.

Hence the recognition granted to G.M.R. College of Education, Plot/Khashra No. 414/1C, Street No. 1, Tadepalli Village & Post, Tadepalligudem Taluk & City, West Godavari District-534101, Andhra Pradesh for B.Ed., D.El.Ed. & D.El.Ed.-Al course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. 2022-2023. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the next academic session i.e. 2022-2023".

7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition G.M.R. College of Education, Plot/Khashra No. 414/1C, Street No. 1, Tadepalli Village & Post, Tadepalligudem Taluk & City, West Godavari District-534101, Andhra Pradesh run by Gayathri Educational Society, West Godavari, Andhra Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) with effect from the academic session i.e., 2022-2023 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
