WHEREAS, the recognition u/s 15 of NCTE Act. 1993 was granted to the institution namely Shri Balaji College of Education, Arcot Road, A.C.S. Nagar, Irumbedu Village, No. 42 Arni-Chennai Highway, Arni Taluk, Thiruvannamalai District-632317, Tamilnadu run by T.M.T Kannammal Education Trust, Arcot Road, A.C.S. Nagar, Irumbedu Village, No. 42 Arni-Chennai Highway, Arni Taluk, Thiruvannamalai District-632317, Tamilnadu vide order F.SRO/NCTE/M.Ed./2008/7359 dated 26.1.2008 for conducting M.Ed. Course of one-year duration with an annual intake of 25 students.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to Shri Balaji College of Education, Arcot Road, A.C.S. Nagar, Irumbedu Village, No. 42 Arni-Chennai Highway, Arni Taluk, Thiruvannamalai District-632317. Tamilnadu vide order No. F.SRO/NCTE/2010-2011/20742 dated 26.08.2010 from the session 2010-2011.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 07.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 22.05.2015 for conducting M.Ed. Programme of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 08.06.2021. The institution submitted reply on 25.06.2021.
- AND WHEREAS, the SRC in its 401st Meeting held on 11th -12th August 2021 5. considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 31.08.2021. The institution has submitted reply on 20.09.2021.
- AND WHEREAS, the SRC in its 409th Meeting held on 29th -30th March 2022 considered the matter and decided as under:-

E-mail: src@ncte-india.org Website: www.srcncte.in "The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on20.09.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution submitted approvals of faculty (one Principal, 2 Professors, 2 Associate Professors, 19 Assistant Professors, 1 Physical director, 1 faculty for fine arts; Total 26). The institution also failed to submit supporting documents in terms of educational qualification of the faculty and experience certificate of the Principal. The faculty strength is not sufficient for B.Ed. (4 units) and M.Ed. (1 unit).
- 2. The institution did not submit the bank statement showing disbursement of salary to faculty through bank account as stipulated under clause 10(2) of NCTE Regulations, 2014.
- 3. The institution did not appoint faculty for Performing Arts.

Hence, the Committee decided to withdraw the recognition granted to Shri Balaji College of Education, Arcot Road, IrumbeduArni Taluk, Thiruvannamalai, Tamilnadu-632317 for conducting <u>B.Ed., B.Ed-Al & M.Ed.</u> programmes with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

7. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Shri Balaji College of Education, Arcot Road, IrumbeduArni Taluk, Thiruvannamalai, Tamilnadu-632317 for conducting M.Ed. programme of two year duration with an annual intake of 50 students (one basic unit) for M.Ed. course with effect from the academic session i.e. 2022-2033 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in

such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
