WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely, Kondapalli Pydithalli Naidu College of Elementary Teacher Education, Gantyada Street, Village & Post, Gantyada Taluk & City, Viziangaram District, Andhra Pradesh-535215 run by Pydithallamma Vydya Vignana Society, Vizianagaram District, Andhra Pradesh for D.Ed. & D.El.Ed.-Al Courses: -

- (i) The SRC vide order no. F.SRC/NCTE/D.Ed./2005-2006/2256 dt. 05.08.2005 for conducting Elementary (D.Ed.) course of two years duration from the academic session 2005-06 with an annual intake of 50 students.
- (ii) The SRC vide order no. F.SRO/NCTE/SRCAPP3178/D.EI.Ed.-Al/AP/2016-2017/85807 dt. 01.06.2016 for conducting D.EI.Ed.-Al programme of two years duration with an annual intake of 50 students (1 unit) from the academic sessions 2017-18.
- 2. AND WHEREAS, the institution has submitted a written representation dated 13.08.2021 for closure of D.Ed. & D.El.Ed.-Al Programme.
- 3. AND WHEREAS, the SRC in its 408<sup>th</sup> Meeting held on 02<sup>nd</sup> March, 2022 considered the request matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution vide dated 08.10.2021 by withdrawing the recognition granted to Kondapalli Pydithalli Naidu College of Elementary Teacher Education, Gantyada Street, Village & Post, Gantyada Taluk & City, Viziangaram District, Andhra Pradesh-535215 for conducting D.Ed. alongwith additional Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Kondapalli Pydithalli Naidu College of Elementary Teacher Education, Gantyada Street, Village & Post, Gantyada Taluk & City, Viziangaram District, Andhra Pradesh-535215 run by Pydithallamma Vydya Vignana Society, Vizianagaram District, Andhra Pradesh for conducting D.Ed. programme (of two years duration with an annual intake of 50 students) &

**D.EI.Ed. -Al programme** (of two years duration with an annual intake of 50 students) with effect from the academic session i.e., 2022-2023 onwards.

**5.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

**6.** Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
