WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Mohamed Sathak Kabeer College of Education, Khasra No. 336/4A and 336/5, ECR Road, Mayakulam Village, Kellakkaral P.O and Taluk, Ramanthapuram District, Tamilnadu-623806 run by Mohamed Sathak Trust, Plot No. 144/1, Nungambakkam Village and P.O., Naugambakkam Taluk and District, Tamilnadu-600034 vide order no. F.No.SRO/NCTE/SRCAPP1845/B.Ed./TN/2015/62220 dt. 03.03.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.

- AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per decision of SRC a First Show Cause Notice was issued to the institution on 22.01.2021. The institution did not submit reply to the First Show Cause Notice.
- AND WHEREAS, the SRC 405th in its meeting held on 13th 14th December, 2021 3. considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 28.12.2021. The institution did not submit reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 409th Meeting held on 29th & 30th March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The institution was issued a Final Show Cause Notice on 28.12.2021. The institution failed to submit reply alongwith the requisite documents/information to the Final Show Cause Notice (FSCN).

Hence the recognition granted to Mohamed Sathak Kabeer College of Education, Khasra No. 336/4A and 336/5, ECR Road, Mayakulam Village, Kellakkaral P.O and Taluk, Ramanthapuram District, Tamilnadu-623806 for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e., 2022-2023. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e., 2022-2023."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Mohamed Sathak Kabeer College of Education, Khasra No. 336/4A and 336/5, ECR Road, Mayakulam

Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.

6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
