WITHDRAWAL ORDER

WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, **Ponnaiyah Ramajayam Institution of Science and Technology-Prist University, No. 99/2, 100/1B, NH 226, Asoor Village & Post, Kumbakonam Taluk & City, Thanjavur District-612501, Tamilnadu** vide order no. F.SRO/NCTE/B.Ed./2008/5124 dt. 22.09.2008 for conducting B.Ed. Course of one year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated nil for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 388th meeting held on 14th – 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report alongwith requisite documents. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 23.09.2020. The institution has submitted reply on 26.11.2020.

4. **AND WHEREAS**, the SRC in its 404th meeting held on 16th – 17th November 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 30.11.2021. The institution did not submit reply to the Final Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 409th Meeting of SRC held on 29th – 30th March 2022 considered the reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Show Cause Notice (FSCN). The institution has submitted its reply. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. **The institution submitted details/proforma of 10 faculty against both B.Ed., BA.B.Ed. course which are not sufficient to run both courses.**

Hence the recognition granted to Ponnaiyah Ramajayam Institution of Science And Technology-Prist University, No. 99/2, 100/1B, NH 226, Asoor Village & Post, Kumbakonam Taluk & City, Thanjavur District-612501, Tamilnadu for BA.B.Ed.&B.Ed. course is withdrawn under Section

17(1) of NCTE Act, 1993 from the next academic session i.e. **2022-2023**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the next academic session i.e. **2022-2023**".

5. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition **Ponnaiyah Ramajayam Institution of Science And Technology-Prist University, No. 99/2, 100/1B, NH 226, Asoor Village & Post, Kumbakonam Taluk & City, Thanjavur District-612501, Tamilnadu** run by **Ponnaiyah Ramajayathammal Educational & Charitable Trust, Thanjavur District, Tamilnadu** for conducting **B.Ed. Programme** of two years duration with an annual intake of **100 students (two basic units)** with effect from the academic session i.e., **2022-2023** onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., **2022-2023** and the institution is also not permitted to take any fresh admission of students from the academic session **2022-2023**.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
