WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely Sri Ankala Reddy Memorial College of Education, Alagadda – 518543, Kurnool District, Andhra Pradesh vide order no. No.F.AP/B.Ed/43/SRO/NCTE/2000-2001/9114 on 24.12.2001 for conducting (B.Ed.) course of one year duration from the academic session 2001-2002 with an annual intake of 140 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 27.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 30.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 150 (three basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the institution submitted reply in compliance to the revised order on 25.06.2015. The SRC in its 314<sup>th</sup> meeting held during 27<sup>th</sup> & 28<sup>th</sup> May, 2016 considered the matter and a VT letter was issued to the institution on 14.06.2016.
- **4. AND WHEREAS,** a letter was received on 13.07.2016 from the institution and the requested that renewal of recognition without inspection for B.Ed. Programme 2 basic units (50 students each) from the academic session 2016-17 onwards.
- **5. AND WHEREAS,** the SRC in its 318<sup>th</sup> Meeting held on 8<sup>th</sup> and 9<sup>th</sup> August 2016 considered the matter and decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 28.09.2016. Before the issuances of Show cause notice as per website information the institution has submitted its reply along with approved faculty list on 27.09.2016.
- **6. AND WHEREAS,** the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup>-15<sup>th</sup> September, 2020 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 07.01.2021. The institution has submitted its reply on 30.01.2021.

7. **AND WHEREAS**, the SRC in its 399<sup>th</sup> meeting held on 15<sup>th</sup> & 16<sup>th</sup> June 2021 considered the matter and decided to issue a last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 01.07.2021. The institution has submitted reply of last reminder letter on 12.07.2021.

- 8. AND WHEREAS, the SRC in its 400<sup>th</sup> meeting held on 13<sup>th</sup> & 14<sup>th</sup> July 2021 considered the matter and decided to issue a Last Reminder Letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 06.08.2021. The institution has submitted reply of last reminder letter on 11.08.2021.
- 9. AND WHEREAS, the SRC in its 402<sup>nd</sup> meeting held on 13<sup>th</sup>- 14<sup>th</sup> September 2021 considered the matter and the Committee decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal order was issued to the institution on 29.09.2021.
- 10. AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P(C) No.1533/2022 & CM APPL. 4388/2022 titled as Sri Ankala Reddy Momorial College of Education versus NCTE & Anr. Whereby the Hon'ble High Court its order dt. 25.01.2022 has directed that:-

"In light of the stand taken by the parties, the application is disposed of by directing that, notwithstanding the impugned order, the petitioner will be permitted to participate in the ongoing counselling session 2021-22. A necessary communication in terms of this order will be sent by the respondent to the affiliating universities and other authorities within one week.

The application is accordingly disposed of with the aforesaid observations."

- **11. AND WHEREAS,** in compliance of order dated 25.01.2022, the Regional Director had issue an order dated 01.02.2022, which was confirmed by the SRC in its 407<sup>th</sup> meeting held on 15<sup>th</sup> February, 2022.
- 12. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-34/E-239087/2022 Appeal/2<sup>nd</sup> meeting, 2022 No.APPLSRC202214262 dated 25.02.2022. Appeal Committee as per extent appeal rules decided that after perusal of the Memoranda of Appeal, Affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to keep the Appeal in question pending till the final outcome of the aforementioned writ petition.
- 13. AND WHEREAS, the Hon'ble High Court of Delhi passed an order dated 28.09.2022 bearing W.P (C) No. 1533/2022 titled as Sri Ankala Reddy Memorial College of Education Versus National Council for Teacher Education & Anr that:-

"Respondents are directed to update the status of petitioner, within a period of one week from today, and send an intimation in respect thereof to the affiliating university of petitioner as well as to the concerned Department of Education to enable them to participate in counseling and admission process for academic session 2022-23.

**14. AND WHEREAS,** in compliance of order dated 28.09.2022, the Regional Director, SRC had passed an order dated 28.10.2022 which was confirmed by the SRC in its 415<sup>th</sup> meeting held on 03<sup>rd</sup> -04<sup>th</sup> November 2022.

15. AND WHEREAS, the Hon'ble High Court of Delhi has directed that order dated 25.07.2023 in W.P (C) No. 1533/2022 which is as under:-.

- "9. Since the case of the petitioner-institution has to be considered afresh in accordance with the applicable regulations, therefore, the impugned orders dated 29.09.2021 and 15.12.2021 deserve to be set aside. The same are, therefore, set aside.
- 10. Setting aside of the impugned orders would not have the effect of restoring the recognition of the petitioner-institution. The restoration of the petitioner-institution would be dependent upon a fresh exercise to be conducted by the respondent-SRC.
- 11. The respondent-SRC is directed to consider the case of the petitioner institution afresh after giving the petitioner-institution an adequate opportunity of hearing.
- 12. Let the petitioner-institution file the requisite representation along with detailed explanation of the steps undertaken to cure the deficiencies noted beforehand, to the satisfaction of respondent-SRC within 7 days from the date of receipt of this order.
- 13. Let respondent-SRC to decide the same in accordance with law within a period of 30 days from the date of receipt of the representation.
- 14. With the aforesaid directions, the instant petition stands disposed of."
- **16. AND WHEREAS,** the institution has submitted a fresh representation on 04.08.2023 of the direction of Hon'ble High Court Delhi order dated 25.07.2023.
- 17. AND WHEREAS, the SRC in its 428<sup>th</sup> Meeting held on 25<sup>th</sup> August, 2023 considered the matter and decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

In the obedience to the Hon'ble High Court of Delhi at New Delhi order dated 25.07.2023 in W.P (C) No. 1533 of 2023 titled Sri Ankala Reddy Memorial College of Education vs NCTE, the Committee decided to issue continuation order to the Institution i.e. Sri Ankala Reddy Memorial College of Education, Alagadda – 518543, Kurnool District, Andhra Pradesh for B.Ed. programme for 2 basic units of 50 students each.

18. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Ankala Reddy Memorial College of Education, Survey No. 702, 703, 696, 699, 535/1, Allagadda, Kurnool District-518543 Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -

I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

I. The institution shall comply with the various other norms and standards prescribed in the

NCTE Regulations, 2014 as amended from time to time.

- The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 19. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 20. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 21. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 22. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

23. The institution shall make available the list of students admitted on its official website.

The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
