WHEREAS, the recognition was granted to the institution namely, Kongunadu College of Education, Tholurpatti, Thottiam Taluk, Trichy District, Tamilnadu-621215 run by Kongunadu Educational Charitable Trust, Trichy District, Tamilnadu for B.Ed. & B.Ed.-Al programme as per following details: -

- (i) The SRC vide order no. F.SRO/NCTE/B.Ed./2006-2007/13482 dt. 24.10.2007 for conducting B.Ed. course of one year duration with an annual intake of 100 students.
- (ii) The SRC vide order no. SRO/NCTE/SRCAPP1889/B.Ed.-Al/TN/2015-2016/66058 dt. 31.05.2015 for conducting B.Ed.-Al programme of two years duration with an annual intake of 100 students (2 units) from the academic sessions 2015-2016.
- 2. AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 19.01.2015, the provisional revised recognition order was issued to the institution on 01.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.
- 3. **AND WHEREAS**, the inspection was conduct on 01.12.2016 & 02.12.2016 and VT report received on 06.12.2016. The institution has submitted reply to the Show Cause Notice on 16.08.2021.
- **4. AND WHEREAS,** the SRC in its 388^{th} meeting held on $14^{th}-15^{th}$ September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC Show Cause was issued to the institution on 03.08.2021. The institution vide letter dated 16.08.2021 submitted reply to the Show Cause Notice.
- **5. AND WHEREAS,** the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Kongunadu College of Education, Survey No.283/1A, 1B,1C,2A, 284/3A,3B,3C,285/3A, Tholurpatti Pachayat, Thottiam Taluk, Tiruchappalli District-621215, Tamilnadu for B.Ed. programme for 4 basic units of 50 students each."

- 6. NOW THEREFORE, this order is issued permitting the institution i.e., Kongunadu College of Education, Survey No.283/1A, 1B,1C,2A, 284/3A,3B,3C,285/3A, Tholurpatti Pachayat, Thottiam Taluk, Tiruchappalli District-621215, Tamilnadu runs by P.S. Ramasamy Telugu Minority Educational and Charitable Trust, 9-E, N.P.S.N. Arumugam Road, Sivakasi Taluk, Virudhunagar District, Tamilnadu-626123 for Continuation of recognition for B.Ed. & B.Ed.-A.I. programme for two years duration with annual intake of 2 basic units & 2 basic units of 50 students each subject to fulfilment of the following conditions:
 - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in

the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV. The institution shall ensure that the required number of academic staff duly approved

by affiliating body for conducting the course should always remain in position.

- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9.  - e. Fee charged from students.
 - Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.

- i. The institution shall be free to post additional relevant information if it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **10**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.
