WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely Pratap College of Education, Ramapuram Village, Papayapalem Post, Vetapalemm Chiral, Prakasam District – 523157, Andhra Pradesh run by Pratap Educational Society, Prakasam District, Andhra Pradesh. The SRC vide order F.SRO/NCTE/APS07001/B.Ed./2006-2007/2190 dt.01.05.2007 for conducting (B.Ed.) course of two-year duration from the academic session 2006-07 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 20.01.2015. A Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.

3. **AND WHEREAS**, the SRC in its 363rd meeting held on 17th – 19th September 2018 considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 12.10.2018. The institution vide letter dated 15.11.2018 received on 19.11.2018 submitted reply to the Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a **Final Show Cause Notice** was issued on 15.11.2019. The institution vide letter dated 12.12.2019 submitted reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the matter was further considered by the SRC in its 392nd meeting held on December 15-16, 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution in respect of Final Show Cause Notice issued on 15.11.2020. The Committee observed the following deficiencies: -

1. The institution has not submitted certified copy of land document.
