WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **PSB College of Education, Prathipati Nilayam, Woodnagar, Chirala, Prakasam District – 523155, Andhra Pradesh** run by **Sri Venkateswara Educational Society, Prakasam District -523155, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/APS07312/B.Ed/2006-2007/780 dt 12.07.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, the Government of Andhra Pradesh vide letter dated 06.03.2007 forwarded a list of institutions not recommending them with the specific reasons and with a request to NCTE, SRC to take necessary action against the institutions. This institution is one of the institutions not recommended by the State Government.

AND WHEREAS, the SRC considered this issue in its 150th meeting held on 28th-29th December 2007 and decided to conduct the inspection of the institution under section 17 of NCTE Act, 1993. Accordingly, the inspection of the institution was carried out on 23.04.2008. The report was considered by SRC in its 161st meeting held on 6th-7th August 2008 whereby it was decided to issue a show cause notice as to why the recognition granted not be withdrawn on account.

AND WHEREAS, the institution submitted a reply on 27.09.2008. The Southern Regional Committee in its 166th meeting held on 18th-19th October 2008 after careful consideration of all aspects decided to withdraw the recognition of the institution forthwith i.e., from the academic year 2008-2009. As per the decision of SRC, withdrawal recognition issued on 22.10.2008.

AND WHEREAS, aggrieved by the withdrawal order SRC, the institution preferred an appeal to NCTE H'qrs vide the appellate authority Order dated 19.12.2008 has Conformed the order of SRC. The SRC in its 279 meeting held on 1st February, 2015 considered the matter and decided as under:-

1. Court order seen.
2. There has been no notice to us.
3. There is only an interim order. There is no final order on merits.
4. Ask Lawyer to file an appeal.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 27.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the matter was placed before the Sothern Regional Committee in its 369th meeting held on 28.01.2019. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order. Accordingly, as per the decision of SRC show cause notice was issued to the institution on 31.01.2019. The institution has not submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue Final SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Final Show Cause Notice was issued to the institution on 15.11.2019. The institution did not submit any reply of Final Show Cause Notice.

AND WHEREAS, the SRC in its 392nd Meeting held on 15th & 16th December, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted that the institution has failed to submit reply / written representation in respect to the **Final Show Cause Notice** dt 15.11.2019 issued to the institution.

Hence, the Committee decided to **withdraw the recognition** granted to **PSB College of Education, Prathipati Nilayam, Woodnagar, Chirala, Prakasam District – 523155, Andhra Pradesh** for conducting **B.Ed**, course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Nagarjuna College of Education, Sankarapuram, Nidadvolu Mandal-534303, West Godavari District, Andhra Pradesh** for conducting **B.Ed.** programme of two year duration with an annual intake of 100 students (2 unit) w.e.f. the next academic session.

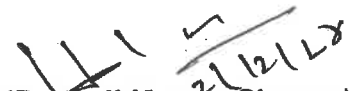
Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school,

College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
