WHEREAS, the recognition was granted to the institution namely Mother College of Education, Jagannadhapuram, Kotananduru Mandal, East Godavari-533407, Andhra Pradesh run by Mother Educational Society, East Godavari, Andhra Pradesh. The SRC vide order F.AP/NEW/B.ED./152 /SRO/NCTE/2002-2003/6140 dt.17.09.2007 for conducting (B.Ed.) course of two-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 24.01.2015. A Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, a Corrigendum was issued to the institution vide order No.F.SRO/NCTE/APS07722/B.Ed./AP/2015/74905 on 06.10.2015 with an annual intake of 50 students for one basic unit from the academic session 2015-16.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 31.01.2019. The institution has submitted its reply on 22.02.2019.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 21.11.2019. The institution submitted vide letter dated 12.12.2019 its reply to the Final Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting held on December 15-16, 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted the reply submitted by the institution on 12.12.2019 in respect to the Final Show Cause Notice, and the Committee made following observations:

- 1. The institution has submitted Notarized copy of Land document in Regional Language instead of Certified copy of it. The institution has not submitted Translated English Version of Land document.
- 2. The institution has submitted a Notarized copy of Building Plan in which Multi-purpose hall Area & Site area are not mentioned.
- 3. The institution has not submitted a Site Plan duly issued by the competent authority.
- 4. The institution has not submitted Building Completion Certificate duly approved by the competent authority.
- 5. The institution has not submitted a letter regarding approval of faculty issued by the affiliating body.
- 6. The institution has not submitted Form "A" issued by the Branch Manager. A copy of Matured FDRs submitted.

Hence, the Committee decided to withdraw the recognition granted to Mother College of Education, Jagannadhapuram, Kotananduru Mandal, East Godavari-533407, Andhra Pradesh for conducting B.Ed, courses w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Mother College of Education, Jagannadhapuram, Kotananduru Mandal, East Godavari-533407, Andhra Pradesh run by Mother Educational Society, East Godavari, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
