WHEREAS, the recognition was granted to the institution namely SAR College of Education, Plot No. 52/1 to 17, 19, to 47, 49 to 60, Street No. 1, Pedamanapuram Village & Post, Dattirajeru Mandal Taluk, Gajapathi Nagaram Cityh, Vizinagaram District – 535580, Andhra Pradesh run by SAR Educational Society, Plot No. 1/118, Gutuchimi Main Road, Gutuchimi Village & Post, Gattirajeru Mandal, Gajapathinagaram City, Vizinagaram District – 535580, Andhra Pradesh vide SRC (NCTE) order no. F.No. SRO/NCTE/SRCAPP1445/D.El.Ed/AP/2015-2016/78562 dated 07.12.2015 for conducting D.El.Ed course of two-year duration with an annual intake of 50 students from the academic session 2016-2017.

**AND WHEREAS,** The institution vide letter dated 07.11.2019 submitted written representation for closing. The SRC in its 392<sup>nd</sup> meeting held during 15<sup>th</sup> & 16<sup>th</sup> December, 2020 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to SAR College of Education, Plot No. 52/1 to 17, 19, to 47, 49 to 60, Street No. 1, Pedamanapuram Village & Post, Dattirajeru Mandal Taluk, Gajapathi Nagaram Cityh, Vizinagaram District – 535580, Andhra Pradesh for conducting D.El.Ed course under clause 17(1) of NCTE Act, 1993 on its own request by the institution. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

(a) NOC from the affiliating body.

(b) NOC from the staff/faculty.3

(c) Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of SAR College of Education, Plot No. 52/1 to 17, 19, to 47, 49 to 60, Street No. 1, Pedamanapuram Village & Post, Dattirajeru Mandal Taluk, Gajapathi Nagaram Cityh, Vizinagaram District — 535580, Andhra Pradesh run by SAR Educational Society, Plot No. 1/118, Gutuchimi Main Road, Gutuchimi Village & Post, Gattirajeru Mandal, Gajapathinagaram City, Vizinagaram District — 535580, Andhra Pradesh for conducting D.El.Ed programme of two years duration with an annual intake of 50 students (1 unit) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order.
