WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, Sri Tagashri Venka Reddy Memorial College of Education, No. 3-10-1, Gudant Amanayulu Building, Gpp, R.T.C. Bus Stand, Chinnakurthy, Bhalasahi District, Andhra Pradesh vide SRC (NCTE) order no. F.SR/ONCTE/B.Ed/2007-2008/18121 dt. 19.12.2007 (P-251/Cops.) for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 14.01.2015 (P-316/Cops.) for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 06.06.2015 (P-312-313/Cops.) for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-18.

AND WHEREAS, the SRC in its 363rd meeting held on 17th to 19th September, 2018 considered the matter and decided as under:

1. The applicant institution was running a B.Ed. programme.
2. After notification of the 2014 Regulations, because of the increase in the course period from 1 to 2 years, because of increased requirements of facilities (especially of built-up area and faculty), they were given a RPRO and required to furnish documents for verification of satisfaction of the new former standards.
3. The applicant in this case has not adequately responded. Therefore, issue a Show Cause Notice for withdrawal of recognition.
4. If they do not respond satisfactorily, we can proceed to withdraw the recognition given.
5. If they respond satisfactorily, then, we will have to cause a VT inspection to verify the veracity of the claims made.
- 1.1 It upon inspection, all claims are verified to be valid, we can issue a Regular Recognition Order (RRO) under the 2014 Regulations. It is to be recognised that RPROs cannot continue indefinitely, as they are based on facts/provisional.
- 1.2 If upon inspection, the claims are not fully validated, then, we will have to refer the case to NCTE (HQ) for necessary action under section 13 since, according to the Supreme Court decision, we cannot proceed with action for de-recognition based on inspection under section 17.
- 1.3 We had discussed this issue in detail in 361st SRC meeting held on 20th & 28th December, 2017 when we authorized the RD to proceed with action in RPRO cases since SRC was fully engaged in clearing new application cases before the Supreme Court prescribed deadline for issue of RRO.
7. Please put up all such cases together for a common order for similar action.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 12.10.2018. The institution vide letter dated Nil submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 37th meeting held on 09th - 10th April, 2019 considered the matter and decided as under:

The original files of the institution alongwith other related documents, NCTE Act, 1983, Regulations/Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- The institution has not submitted certified copy of land documents.
- Land Use Certificate issued by the Competent Authority.
- Non Encumbrance Certificate issued by the Competent Authority.
- Latest faculty list as per as per the Amended NCTE Regulations, 2017.
- FDRs for Endowment Fund and Reserve Fund.

Hence, the Committee decided to withdraw the recognition under Section 17 (1) of the NCTE Act.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1983, the Southern Regional Committee hereby withdraws recognition of Sri Tarparthivenka Reddy Memorial College of Education, No.3-10-1, Guduri Anjaneyulu Building, Opp. R.T.C. Bus Stand, Chinmakurthy, Prakasam District, Andhra Pradesh for conducting B.Ed (2 Unit) programme of two years duration with an annual intake of 100 students (2 units) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1983 through online mode available on NCTE's website www.ncteindia.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
